<p>On 03/03/18, at approximately 2252 hours, I responded to approximately 300 E Palmetto Park Rd., in reference to a drunk driver. I observed the caller, Tony Granims, driving behind a 2013 white Chevrolet Camaro bearing FL tag# BXRU67. I observed major front end damage to the Camaro. It was missing the front bumper and the headlights were broken and inoperable. The front passenger side tire of the vehicle was also mangled and barely rotating. The passenger side mirror was also broken off and dangling by the wires. The vehicle was slowly driving westbound on Palmetto Park Rd. The vehicle kept stopping in the roadway. I got behind the vehicle and activated my lights and sirens at approximately 100 E Palmetto Park Rd. The vehicle continued westbound on Palmetto Park Rd. and made a right turn onto N Federal Hwy. The vehicle came to a stop at 72 N Federal Hwy.</p> <p>I made contact with the driver, Marta Kuzikyan, who advised she was on her way home. Kuzikyan stated that the vehicle has been damaged for months and that she has been driving on it like that. Kuzikyan had slurred speech and she had glassy eyes with enlarged pupils. Kuzikyan had a difficult time finding her documentation and wasn't able to find her driver's license. Kuzikyan stated she did not have any alcoholic beverages and was not currently taking any medication. Officer Gannon stoodby with Kuzikyan while I spoke with Granims.</p> <p>Granims stated that he saw that Kuzikyan's vehicle had front end damage and did not have function headlights. Granims advised he saw Kuzikyan swerving between multiple lanes driving eastbound on E Palmetto Park Rd. Granims saw Kuzikyan hit a construction sign that got stuck to the front of her vehicle. Kuzikyan mad a Uturn to head westbound on Palmetto Park Rd. The sign that was stuck to the vehicle was hit parked cars along Palmetto Park Rd. Granims stated he followed the vehicle until I arrived.</p> <p>I then walked back to Kuzikyan and asked if she could step out of her vehicle, so I</p>

could ask her some questions, which she consented. Kuzikyan was unable to get out of the driver side door. The door was damaged and unable to fully open. Kuzikyan then crawled over to the passenger door and climbed out. Kuzikyan was extremely unsteady on her feet. I advised Kuzikyan that I had reason to believe she was driving under the influence and asked if she would attempt the standard road side sobriety tasks to dispel my alarm that she was impaired. She stated she would. She stated she had no injuries and does not currently take any medications.

The first task was the walk and turn. Kuzikyan was unable to stay in the starting position while I gave her the instructions. She stepped off of the line several times to keep from falling. She did not touch heel to toe on each step. She walked ten steps, turned, and walked ten steps back. She stepped off the line several times while walking. The second task was the one leg stand. Kuzikyan did not count in the manner I told her in the instructions. She counted one, two, three,... instead of one thousand one, one thousand two, etc. She dropped her foot several times during the task. She almost fell over during the task and was swaying the entire time.

The third task was the finger to nose (L-R-L-R-R-L). She was unable to keep her head tilted back during the task. She missed the tip of her nose on each movement. She touched her cheek on each movement and would make her way to the tip of her nose. She kept her finger on her nose for an extended period of time and only brought it back to her side after my repeated instruction to do so.

The fourth task was the rhomberg alphabet. She was able to recite the alphabet with no issues, however she had very slurred speech.

The fifth task was the horizontal gaze nystagmus. There was a lack of smooth pursuit in each eye. There was distinct and sustained nystagmus at maximum deviation in each eye. Onset of nystagmus prior to 45 degrees in each eye.

At 2338 hours, I placed Marta Kuzikyan under arrested for DUI per F.S.S. 316.193(4). Kuzikyan was transported to the PBSO BAT for breath analysis. Kuzikyan consented to giving a breath sample. Her breath samples were .000, and .000. Kuzikyan consented to giving a urine sample.

The vehicle was towed to Emerald Towing.

While at PBSO BAT, BRPD units informed me that the bus stop at 1921 N Federal Hwy was destroyed, along with three street signs. The front bumper of the Camaro was found alongside the signs.
