DUI ALCOHOL OR DRUGS

PROBABLE CAUSE

On July 20, 2017 at approximately 9:27pm I, Tpr. J. J. Vega, was stopped at a steady red light on Northlake Blvd in the left turn lane facing east. I observed a grey Hyundai with Florida plate number Y04URM, driving east through the steady red light east on Northlake Blvd and Interstate 95 Intersection. I proceeded to activate my emergency lights and sirens and overtook the vehicle. The driver stopped on Sandtree Drive off Northlake Blvd (In the plaza off Sandtree). The driver of the vehicle immediately exited the car and began to walk towards my patrol car, using his left hand and left leg for balance against his car. I asked the driver to get back in the vehicle. Tpr. D. X. Wright told me he can come out and to walk to the vehicle. I then asked the driver why he had drove through the steady red light. While the driver spoke, I observed a strong odor of an alcoholic beverage coming from his facial area, the driver was not able to keep his balance and his speech was slurred. I proceeded to ask the driver to move the car and was reluctant to do so. Tpr. Wright asked the driver to walk to the front of the patrol car. I then went walked towards the car then moved the car into the shopping plaza off Sandtree Drive (due to officer safety, the car was blocking a busy entrance and exit of the plaza). I proceeded to put the car in park, and turn it off. I identified the driver by his Florida Driver's license.

During the next phase of the traffic stop, I explained to the driver the reason for the stop was for driving through a steady red light. The driver replied "No, I'm just going home". As I was standing in front of him, I again observed an strong odor of an alcoholic beverage coming from the facial area, his speech was slurred, glossy eyes, and was unable to keep balance. Tpr. Wright then asked the driver if he had anything to drink and he said he had a couple to a few drinks (wine). Tpr. Wright asked how many drinks was a couple and he couldn't answer. Tpr. Wright and I then asked the driver if he would perform Field Sobriety Exercises to see if he was okay to drive. The driver stated "Yes". Tpr. Wright explained that I, Tpr. Vega, was going to explain the Field Sobriety Exercises and Tpr. Wright was going to repeat them to make sure he understood.

I, Tpr. Vega, told the driver to stand with his feet together, and said "No, I'm just going home". Tpr. Wright asked him to put his eyeglasses up to his head or hold them in his hands, to check his eyes. The driver proceeded to do so, then put his glasses back down from his head. I, Tpr. Vega, then told him to face me, and the driver stated "No, I'm just going home, to follow him there". Tpr. Wright explained that if he doesn't perform the Field Sobriety Exercises it could be used against him in court and he'll be arrested for DUI, the driver said no to the exercises. I, Tpr. Vega, placed the driver under arrest for driving under the influence at 9:32pm. The driver was searched and placed in the back of the patrol car. He was transported to the Palm Beach County Jail.

Once at the jail, the driver brought to the breathalyzer area once inside the jail. Martin Mario Satori, twenty-minute observation started at 10:22pm and I observed him for a full twenty-minutes. the driver did not place anything in his mouth, or regurgitated. The driver provided two good breath samples both were over the Florida legal DUI limit. He was then transferred custody to the Palm Beach County Sheriff's office.
