On 04/12/2018, at approximately 2251 hours, I conducted a traffic stop on a Grey, 2018, Infinity SUV bearing Florida tag GWGE38 for improper parking. The vehicle was parked in a handicap parking space, however, non of the occupants were handicap.

Prior to the stop, I watch Brian Nashick, exited the driver seat and sat in the back seat. As I approached on the driver side, based on my training and experience, I saw Brian smoking what I know to be rock cocaine "crack" from a glass pipe. I also observed a white substance on top of the arm rest where Brian was sitting, which appeared to be rock cocaine.

Deputy Herzog #13023 detained Brian as I made contact with the front passenger, Mary Cannon. Mary was also detained pending a narcotics investigation. Prior to searching the vehicle, Mary advised she had Heroine caps inside her purse. I conducted a search of her purse and located 8 caps of heroine inside the purse. The heroine was not field tested due to potential hazard but weighed approximately 0.9 grams. I also located 2 Delaudid, which are classified as schedule two drugs. A short while after, Mary told me she had "hard" inside her bra. "Hard" is street terminology for cocaine. Mary admitted to selling the heroine, however, stated the cocaine and delaudid were for her personal use.

The cocaine (crack) was recovered from Mary's bra by Sgt. Rogen. The recovered cocaine field tested positive for cocaine and weighed approximately 2.3 grams.

Mary was placed under arrest for possession heroine pursuant to Florida State statue 893.(6A), possession of heroine with intent F.S.S 83.13(1A1), possession of cocaine F.S.S 893.13(6A) and possession of schedule two drugs F.S.S 893.13(6A)

The recovered evidence was later placed into PBSO district 5 evidence locker.

Mary was later transported to the Palm Beach County Jail without incident.
