

I was stopped facing west at the intersection of W. Gateway Blvd. and I 95 for the red traffic signal. I observed a gray Ford F150 pickup truck exiting I95 northbound ramp turning left (west bound). The exit ramp consists of two left turn lanes; the target vehicle was occupying the left turn lane. As the target vehicle entered the intersection, the driver changed from the left lane to the right turn lane pulling directly in the path of a Kia Optima (possibly gray or silver). I activated my emergency red and blue lights and waited for the vehicular traffic to clear. Once the intersection was clear I drove west on W. Gateway Blvd and observed several more vehicles braking as the same Ford F150 was changing lanes. The vehicle was entering the right turn lane to travel north on Highridge Road. The vehicle continued north on Highridge Road at an estimated speed of 65 mph. This portion of the roadway is 30 mph. I was able to catch up to the target vehicle as it was turning into Cedar Ridge Community. The target vehicle made it through the gate and turned right onto Spruce Street. No more than 10 seconds elapsed and I was able to gain access into the community. I was the first vehicle that entered the Community after the target vehicle. As I pulled onto Spruce St and followed the roadway I located the same vehicle as it was backing into the driveway of 117 Spruce St. I pulled in front of the vehicle and exited my marked patrol vehicle. I made contact with the sole occupant (driver) later identified as W/M Massimo Mazzocchi d.o.b. 11.23.73 (by Florida D/L). I explained the purpose for my presence and requested his driver's license and vehicle information. In speaking with Mazzocchi, I could detect the odor of an alcoholic beverage emanating from his breath, which intensified as he spoke. Mazzocchi's eyes were glassy and blood shot and his speech was thick and slurred.


Based on the driving pattern, Mazzocchi's physical indicators, and my training and experience as a previous DUI Enforcement Officer I believed that Mazzocchi was impaired. I briefed Officer N. Davis ID#918, who took over the DUI investigation. Once Mazzocchi was taken into custody and transported to the BB PD booking facility, I was the breath tech operator for this case. Ofc. Davis requested Mazzocchi provide a sample of his breath for the purpose of determining the alcohol content, which he refused.

D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT/DRIVING PATTERN/OBSERVATION OF DRIVER:

On the above date and time, I responded to 117 Spruce St in reference to a possible DUI. Upon arrival, I met with Sergeant Turco who advised the following:

"I was stopped facing west at the intersection of W. Gateway Blvd. and I 95 for the red traffic signal. I observed a gray Ford F150 pickup truck exiting I95 northbound ramp turning left (west bound). The exit ramp consists of two left turn lanes; the target vehicle was occupying the left turn lane. As the target vehicle entered the intersection, the driver changed from the left lane to the right turn lane pulling directly in the path of a Kia Optima (possibly gray or silver). I activated my emergency red and blue lights and waited for the vehicular traffic to clear. Once the intersection was clear I drove west on W. Gateway Blvd and observed several more vehicles braking as the same Ford F150 was changing lanes. The vehicle was entering the right turn lane to travel north on Highridge Road. The vehicle continued north on Highridge Road at an estimated speed of 65 mph. This portion of the roadway is 30 mph. I was able to catch up to the target vehicle as it was turning into Cedar Ridge Community. The target vehicle made it through the gate and turned right onto Spruce Street. No more than 10 seconds elapsed and I was able to gain access into the community. I was the first vehicle that entered the Community after the target vehicle. As I pulled onto Spruce St and followed the roadway I located the same vehicle as it was backing into the driveway of 117 Spruce St. I pulled in front of the vehicle and exited my marked patrol vehicle. I made contact with the sole occupant (driver) later identified as W/M Massimo Mazzocchi d.o.b. 11.23.73 (by Florida D/L). I explained the purpose for my presence and requested hi driver's license and vehicle information. In speaking with Mazzocchi, I could detect the odor of an alcoholic beverage emanating from his breath, which intensified as he spoke. Mazzocchi's eyes were glassy and blood shot and his speech was thick and slurred. Based on the driving pattern, Mazzocchi's physical indicators, and my training and experience as a previous DUI Enforcement Officer I believed that Mazzocchi was impaired. I briefed Officer N. Davis ID#918, who took over the DUI investigation."

I then met with Mazzocchi near the entrance of his driveway of 117 Spruce St. I introduced myself and advised the reason for my presence, to which he understood. As I spoke to him, I observed that his eyes were blood shot red and his face appeared flushed. I also could detect the odor of an unknown alcoholic beverage coming from his mouth that increased as he spoke.

Based on Sergeant Turco's observations and my interactions, I asked Mazzocchi to complete a series of Standard Field Sobriety task to which he responded "I ain't doing shit!" He then began explaining to me that his truck has been in his driveway and was not driving. He also stated he was not "drunk" and he was never stopped during a traffic stop. I then explained to him that the statement "I ain't doing shit!" can be accepted as a refusal and could be used in any criminal proceedings. He again refused to perform any task. He was given several opportunities to perform the tasks but refused each time.
