On 08/24/19 at 0245 hrs. I was patrolling the area on Southern Blvd and Royal Palm Beach Blvd in the Village of Royal Palm Beach in my unmarked patrol unit. I observed a silver Nissan titan bearing Florida tag IM92TI driving westbound at a high rate of speed from 103rd Ave. The vehicle began to maintain a single lane and started swerving between lanes. At one point the vehicle reached speeds of 75 mph on a wet recently rained road. I then attempted to continue behind the vehicle to attempt a traffic stop when the vehicle suddenly slammed on his brakes in the middle of the road. I then activated my emergency lights and conducted a traffic stop. I immediately observed a male the seemed to be intoxicated in the back seat sleeping and a passenger with extremely blood shot eyes. I also observed an open bottle of Hennessy cognac on the floor between the passenger and driver. I made contact with Mateo that stated he was just coming from the festival at the fairgrounds on state road 80. I smelled a very strong odor of an alcoholic substance coming from Mateo. His eyes were blood shot and he was very slow to acquire his license and registration. I called a DUI unit to investigate the possibility of the driver being under the influence. The case was turned over the D/S G. Lynch # 8586 when he arrived. Please see D/S Lynch's report for his involvement.

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 8/24/19 I responded to the 13000 block of Forest Hill Blvd, in Palm Beach County, in reference to a traffic stop, with a possibly impaired driver. Upon arrival I met with D/S Tiburcio ID 19480, who initiated the stop.

D/S Tiburcio advised that while on routine patrol he observed a silver Nissan Titan, bearing FL tag IM92TI, traveling west on State Road 80 at a high rate of speed. D/S Tiburcio estimated the speed of the truck to be 75mph in the posted 45mph zone. The truck then suddenly slammed on the brakes, for no apparent reason. D/S Tiburcio made contact with the driver, Mateo Valentin. D/S Tiburcio noticed that Mateo's eyes were bloodshot and his movements were slow/ lethargic. D/S Tiburcio smelled a strong odor of an unknown alcoholic beverage coming from Mateo. D/S Tiburcio observed a bottle of Hennessy on the front floorboard, between the driver and front passenger seat.

OBSERVATION OF DRIVER:

I met with Mateo, who was seated in the driver seat of the truck. I had Mateo exit his truck and stand in front of my patrol car. While standing still, Mateo exhibited a slight orbital sway and his eyes were glassy. I could smell a strong odor of an unknown alcoholic beverage coming from Mateo's breath, which got stronger when he spoke. Mateo advised that he had approximately 4 beers prior to driving. Based on my observations and Mateo's admission to drinking I asked him to perform standard field sobriety tasks. Mateo spoke very little English and D/S Tiburcio translated.

DRIVER'S STATEMENTS:

Mateo stated he had approximately 4 beers prior to driving.

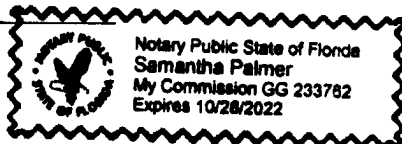

Other Observations:

Mateo was asked to stand with his feet together and place his hands by his sides. Mateo was asked to focus on the stimulus and follow it with his eyes. Mateo was told not to move his head to assist in following the stimulus. Mateo showed equal pupil size that tracked equally. Both eyes lacked a smooth pursuit. I saw distinct and sustained Nystagmus at maximum deviation and onset of Nystagmus prior to 45 degrees in both eyes. I did not observe any vertical nystagmus in either of Mateo's eyes. Mateo exhibited a sway while performing this task.

WALK & TURN:

I utilized yellow duct tape to make a straight level line, free of debris, that Mateo advised he could see. I explained and demonstrated the task to Mateo. During the instructions Mateo was unable to maintain the instructional position, stepping out of the position. After completing the instructions Mateo advised he understood and had no questions. During the task Mateo stepped off the line 3 times. After the first nine steps Mateo had to be instructed to continue. Mateo did not turn as instructed.

ONE LEG STAND:

I explained and demonstrated the task to Mateo. After completing the instructions Mateo advised he understood and had no questions. During the task Mateo exhibited an orbital sway and used his arms for balance. Mateo put his foot down twice prior to 30 seconds elapsing. Mateo failed to keep his leg straight during the task.

FINGER TO NOSE:

I explained and demonstrated the task to Mateo. After completing the instructions Mateo advised he understood and had no questions. During the task Mateo missed touching the tip of his nose several times. Throughout the task Mateo exhibited an orbital sway.

ROMBERG ALPHABET:

Prior to beginning the task Mateo confirmed he knew the entire alphabet, in Spanish. I explained and demonstrated the task to Mateo. After completing the instructions Mateo advised he understood and had no questions. During the task Mateo exhibited an orbital sway. Mateo correctly recited the alphabet.

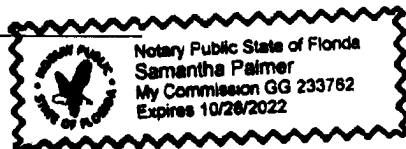
