NARRATIVE:

The undersigned has probable cause to believe the above-named defendant on 29 of April 2018 at 16:21 at LAKE BOCA FWC (Zone: W50) in Palm Beach County did

On Sunday April 29, 2018, at approximately 4:30PM, I, Officer Julian Keen of the Florida Fish and Wildlife Conservation Commission was on water patrol at Lake Boca. I made contact with Matthew Stagnone who was operating his vessel on the wrong side of the channel.

During the vessel stop I requested to see his boating safety equipment. Stagnone had trouble finding his life jacket that was in plain site. He fumbled around the vessel trying to find the life jacket. I noticed Stagnone swaying while standing in the vessel. Stagnone did not have any safety equipment violations.

I observed Stagnone to have blood shot eyes, he was swaying swaying, avoiding eye contact, and he admit to drinking.

At this time, I initiated a boating under the influence investigation. I asked Stagnone to perform Seated Field Sobriety task.

The first task was the Horizontal Gaze Nystagmus. Stagnone showed the following signs of impairment, Lack of smooth pursuit in both eyes Distinct and sustained nystagmus at maximum deviation in both eyes Onset of nystagmus prior to 45 degees in both eyes Vertical nystagmus in both eyes

The second task was the finger to nose Stagnone showed the following signs of impairment: The First left he hesitated, searched, did not touch finger tip, missed tip of his nose, and did not bring his hand down The first right he hesitated, searched, did not touch finger tip, missed tip of his nose, and did not bring his hand down The second left he searched, did not touch finger tip, missed tip of his nose, and did not bring his hand down The second right he searched, did not touch finger tip, missed tip of his nose, and did not bring his hand down The third left he searched, did not touch finger tip, missed tip of his nose, and did not bring his hand down The third right he searched, did not touch finger tip, missed tip of his nose, and did not bring his hand down
