

 On the **22** day of **February**, **2018** at **17:26** (Specifically include facts constituting cause for arrest.)

On Thursday, February 22nd, 2018, at 5:00pm, while on an off-duty detail at PGA National Resort during the Honda Classic Golf Tournament located at 400 Avenue of the Champions, Palm Beach Gardens, Palm Beach County, Florida, I responded to our command post in reference to a grand theft of a golf cart.

Upon arrival, I met with Gerald Burris who witnessed the suspects on the golf cart. Burris advised that he was picking up a co-worker near the 17th hole on the golf course and noticed two males. (driver was wearing a dark blue hat and passenger was wearing a white hat) on a resort golf cart. The two subjects appeared to be spectators rather than employees and/or volunteers of the Honda Classic. They were also seen drinking alcoholic beverages on the golf cart. Burris followed the suspects up to the front of the course and made contact with them. A sworn verbal statement was captured on my body worn camera.

I obtained a verbal sworn statement from Jill Barry, who advised that she was with Burris and saw the above-mentioned suspects on the golf cart as well. Barry stated that she noticed that the two suspects did not have the proper attire and or credentials to be on the golf cart.

I made contact with Josh Cole who is the Director of Outside Operations for the PGA National Resort. Cole stated that he was near the front of the course and noticed two males on a resort golf cart who did not appear to authorized to be on a golf cart. As Cole watched the cart, he noticed that it was cart number 24 which was a cart they had been missing. Cole stated that on February 21st after the tournament they noticed that cart 24 was not inside their charging station. Cole advised that it was not reported because at the time he did not think it was stolen and rather forgotten on the course. At that time, Cole followed the subjects and was able to make contact with them near the "Practice green" at the front of the course. The cart belongs to PGA National resort

and it valued at \$5,500. Cole provided me with a verbal sworn statement captured on my body worn camera confirming prosecution.



I spoke to the passenger Sean Finn who was wearing a white hat with a green shirt. Post-Miranda, he stated that they found the golf cart near the 17th hole and decided to take it for a ride up to the front. Finn stated that due to his career as a golf pro he had a set of keys that operated these types of golf cart. According to Finn, the original keys for the golf cart were not in it. Finn admitted to taking the golf without authorization. Finn stated that Sheperd was driving the golf cart but the keys they used belong to him.

Post-Miranda, I spoke with Matthew Sheperd and he stated that they found the cart near the 17th hole and they decided to take it instead of walking. He advised that they just took it for a ride because they were "just kids having fun". Sheperd also admitted to taking the golf cart without authorization.

Based on the above facts and circumstances, Matthew Sheperd was arrested and is charged with one count of Grand Theft \$300-\$20,000 in accordance with F.S.S. 812.014 (2) (C) (1). Sheperd was transported to the Palm Beach County jail without incident.

My body worn camera was utilized during this investigation.
