

██████████ was one of the 'decoys' posing as a prostitute at 3rd Avenue North and North Dixie Highway in the City of Lake Worth FL.

██████████ was approached by a W/M later identified as Matthew Dardick who was driving an Orange Kia Soul bearing FL Tag "384NRC".

Upon the defendant's contact with the deputy, a conversation ensued. During the conversation, "Hey, are you looking for me? He replied yeah. ██████████ said "Ok what are you looking for? He stated "Just some head". D/S Stoupis asked him how much he had on him, he said "\$40". ██████████ told him that was fine and to meet me around the alley where she was staying with a friend.

The predetermined signal was given where the arrest team responded from a concealed location. D/S Sowers #9187, D/S Gareau #17740, D/S Schiller #8300 and D/S Tembeckjian stopped the Defendant and took him into custody without incident.

Based on the above facts listed above probable cause exists for the arrest of the defendant for SOLICITING ANOTHER TO COMMIT PROSTITUTION per F.S.S 796.07 (2)(F).
