Matthew was unable to stand up straight while having slurred speech and an unknown alcoholic odor coming from his breath. Matthew was told to leave the area due to him causing patrons/businesses from the surrounding area to stop what they were doing to watch Matthew cause a disruptive scene.</p> <p>Matthew was given multiple warnings to leave the area and escorted away from the nightclub giving him the opportunity to leave. Matthew returned to the club while starting to argue with myself and other officers causing a disturbance.. Matthew was arrested for disorderly Intoxication placed in handcuffs which were checked for fit and double locked per department policy. It should be noted that while placing Matthew in handcuffs he started to resist officers by tensing up his arms and hands to prevent us from placing handcuffs on. Matthew was then placed against the wall of the Pawn Shop nightclub for better control of his person. Matthew was transported to PBCJ without incident.
