	On 12/3/2019 at approximately 0146 hrs I was facing south bound on Military Trail at Frederick Small Road. I observed a Grey Mitsubishi bearing FL tag GWC-U82 (VEHICLE-1) coming towards me, on the north bound side of Military Trail at a high rate of speed. I visually estimated the speed to be 60 MPH (45 MPH zone). I activated my Talon II Radar, heard a clear audio Doppler tone consistent with that speed and observed a radar speed readout of 60 MPH. I then followed the vehicle, where I pace clocked it in my calibrated vehicle #1307 at varying speeds between 60 MPH and 70 MPH north bound on Military Trail. As the vehicle approached Indian Creek Parkway I observed that all north bound lights were red. I observed as the vehicle slowed and then made a right, east bound turn, onto Indian Creek Parkway, without coming to a complete stop. I activated my lights and attempted to conduct a traffic stop on the vehicle. The vehicle initially slowed to my lights and then kept driving. I activated my siren a couple of times in an effort to get the vehicle to yield. The vehicle traveled east bound and then took a north bound turn on Black Ironwood Road. The vehicle continued traveling, at which point it took a right turn on W Pigeon Plum Drive. I advised over the radio that I had a vehicle failing to yield to me at a slow speed. The vehicle finally stopped in front of 108 W Pigeon Plum Drive. Due to my concern that the driver was attempting to evade me in response to some criminal activity, I ordered the driver to step out of the vehicle and exit to the rear of the car. At this point I made contact with the driver, Matthew Templeton (DEFENDANT) at the rear of the vehicle. During my initial contact with Templeton I observed that he had red, glassy bloodshot eyes. He advised me that he did not pull over because there was not a safe place to. He acknowledged seeing my lights but kept advising me that there was no place to pull over. While speaking to Templeton I observed now that he also had slurred speech. He stated he was coming from playing poker. I asked him how much he had to drink and he stated not much. I asked how much that was and he stated he had nothing to drink. I

conducted a quick nystagmus evaluation and observed nystagmus, at which time I asked him if he had taken any medication. He stated he takes medicine for depression and his blood pressure. Based on my observation of him and his driving behavior, I was concerned that he was showing signs of possible alcohol and/or drug impairment. Templeton consented to field sobriety exercises. Once I began the exercises I detected a strong odor of unknown alcoholic beverage emitting from Templeton, which intensified as he spoke. He would later admit to having drinks at poker. Based on my observations and investigation, I have probable cause to believe that Matthew Templeton was in actual physical control of a motor vehicle while under the influence of an alcoholic beverage and/or a chemical or controlled substance. I placed him under arrest at 0206 hrs. While on scene I learned through a DAVID/NCIC/FCIC check that his license was suspended on 11/26/2018. This was without knowledge. I then transported him to the Palm Beach County Breath Alcohol Testing (BAT) center, arriving at 0235 hrs. I placed him under a 20 minute observation period, during which I did not observe him consume nor regurgitate anything. We then went on video with BAT Technician Palmer (ID #24520). I requested a breath sample and Templeton refused. I read implied consent and he seemed confused by it so I explained the part that applied to him. He refused again, with a marked refusal time of 0301 hrs. I read him his Miranda rights and he refused to speak to me without an attorney. Based on my investigation I have probable cause to charge Templeton with DUI pursuant to F.S.S. 316.193(1). In addition, I have probable cause to believe that Templeton willfully failed and refused to comply with a lawful order or direction, to wit, by failing to pull over as indicated by blue/red lights and sirens. I additionally issued Templeton citations for speed violation and driving on a suspended driver's license without knowledge. He was issued a court date of 01/08/2020 at 0830 hrs at the North County Courthouse in Palm Beach Gardens, FL. The vehicle was towed from the scene by All Hooked Up towing. BWC.
