am and dispatch advised the vehicle was traveling northbound north of State Road 806 (Atlantic Ave). Dispatch advised the caller was still landline and behind the BOLO vehicle. The caller was in a black in color Dodge Dart. I traveled southbound from State Road 812 (Lantana Rd) and exited at State Road 804 (Boynton Beach Blvd). I was advised that the vehicle was passing Woolbright Rd. I pulled over just north of Gateway Blvd on the right shoulder. I observed through my rear view mirror a red in color sedan, and directly behind the vehicle was a black in color dodge with its hazards on. As the vehicle passed, I noticed it was traveling at a slow speed, way below the speed limit. I proceeded to go behind the vehicle get a driving pattern of that vehicle. I paced the vehicle traveling in the center lane approximately 35 Miles Per Hour in a posted 65 mph zone. The vehicle was swerving heavily in its lane and crossing over the lane lines into adjacent lanes. The vehicle was bearing a Florida Tag of ANTN51. I observed the vehicle speed up to 55mph. As we were approaching Hypoluxo Rd, the vehicle had it's right turn signal on. The vehicle crossed over the apex to exit onto to Hypoluxo Rd. I then activated my emergency lights and siren to conduct a traffic stop on that vehicle. The vehicle pulled over on the right on the exit ramp.

I approached the driver's side and came in contact with a white male in the driver's seat. I identified myself and explained the reason for the stop. I asked the subject where he was coming from and he advised he was coming from his girlfriend's house in Boca Raton. I asked the subject for his driver's license, registration, and insurance. His responses were slurred and lethargic at times. His eyes were bloodshot/watery and I could smell the strong odor of alcoholic beverage coming from his breath. I identified the driver by his Florida Driver's License (D200-556-77-469-0) as Matthew Robbie Sidney Dyke. Based on Mr. Dykes driving pattern and the indicators of impairment that I had observed, I asked Mr. Dyke if he would perform field sobriety exercises. Mr. Dyke refused to do the exercises. I asked him a second time if he would perform the exercises and he stated he would not. I advised Mr. Dyke that if he did not perform the exercises, I will place him under arrest.
