Ambrogio said that Marasco then handed the shopping bag to Young and both defendants exited the store passing all points of purchase and made no attempt to pay for the merchandise they had concealed in the Macy's bag.</p> <p>Ambrogio said she stopped the two defendants out in the mall as they exited the store and identified herself as Loss Prevention and escorted them to the security office where she called police. 
