On the 6 day of July, 2018 at 18:59 (Specifically include facts constituting cause for arrest.)

On 7/6/2018, at approximately 1820 hours, I responded to the rear of 5455 N Federal Hwy to assist with the traffic stop of a hit and run suspect. Upon arrival, I met with BRPD Sergeant Daly who initiated traffic stop on the white Volkswagen Jetta (FL - CRHT81).

Sergeant Daly stated that the damage and description of the vehicle matched the BRPD BOLO which was put out at the same time by a traffic unit. Sergeant Daly stated that the driver, Meagan Wilsey, was in the driver's seat and was the sole occupant of the Volkswagen Jetta (FL- CRHT81). See his supplemental report regarding his interaction with the vehicle and driver.

I made contact with Wilsey, whom was still sitting in the driver's seat of her white VW Jetta. While I was speaking with Wilsey, I smelled a strong odor of an alcoholic beverage coming from her person. I asked her if she had sustained any injuries from her vehicle accident, to which she replied no. Wilsey uttered, "just take me to jail".

Wilsey made it very clear that she did not wish to talk about the vehicle accident but stated repeatedly throughout our interaction that she was "sorry". Having a strong suspicion that she was inebriated, I concluded my accident investigation and began conducting a DUI investigation. I informed Wilsey of her constitutional rights, to which she replied, "oh you mean my Riranda Rights". I said yes, those rights, and then read her the Miranda warnings from a pre-printed agency issued BRPD card. Wilsey acknowledged her rights and stated that she would not speak to me about what happened. I then requested that Wilsey perform the Standard Field Sobriety Tasks to dispel my alarm that she was driving impaired, to which she refused. I advised Wilsey that if she would not perform the SFST as I had requested, that I would be forced to make a decision on her impairment based solely on my interaction and investigation up to that point. Wilsey acknowledged me and stated once again that she would not perform the tasks.

I then placed Wilsey under arrest and into handcuffs (double-locked) and sat her in the back of my patrol car to wait until a female officer could respond to assist with a search of her person incident to arrest. Officer Murphy arrived on scene shortly and completed a search. No contraband was found.

Concerning the initial vehicle collision prior to my interaction with Wilsey, Officer Codling provided a written statement of the driver involved in the collision, Chelsea Dibernardo. Dibernardo stated that while stopped at a red light, a white VW Jetta rear ended her and simultaneously pushed her vehicle into the car directly in front of her. As the driver in front of her called 911 to report the collision, Dibernardo stated that the driver of the vehicle that hit her, a W/F with blonde hair and wearing a white top, got back into her vehicle and left the scene. Dibernardo was able to take a picture of the Jetta's license plate prior to it leaving, (FL - CRHT81) and also relayed the information of the damage and description to the responding officers.

Following the traffic accident investigation, Officer Renteria facilitated a transport for Dibernardo to my location at 5455 N Federal Hwy for a show-up, and to see whether or not she could identify Wilsey as the driver who rear ended her. Dibernardo positively identified Wilsey as the driver who hit her and left the scene. The conditions at the time of the show-up was daylight with optimal lighting conditions. See Officer Renteria's supplemental report for more. Let it be known that the location where Wilsey was finally stopped was several miles away from where the initial traffic collision happened.

With a positive identification of Wilsey as the driver of the VW Jetta, the front-end damage to her vehicle, as well as the exact match of the license plate scene by the witness, I was able to determine that Wilsey was in violation of F.S.S. 316.061(1), Leaving the scene of a vehicle accident.

Wilsey also stated that she had knowledge of her Florida driver's license being suspended 2 days prior after receiving a letter from DHSMV in reference to her interlock device being removed from her vehicle. She was found in violation of F.S.S. 322.34(2), DWLS with knowledge.

Wilsey was arrested for DUI with property damage, per F.S.S. 316.193(3C1) and transported to Boca Raton for processing. Officer Van Camp operated the Intoxilyser 8000. While in the DUI room, I requested Wilsey to provide a legal sample of his breath, which she refused. I then read her Implied Consent to which she once again refused.

Additionally, Wilsey did have a prior refusal to provide breath, urine, or blood in reference to a DUI investigation. Wilsey also has 2 prior DUI arrests. The additional charge of F.S.S. 316.1939(1) will be applied.

On 7/6/18 at approximately 1800 hours I was traveling westbound on E. Yamato Rd. approaching the intersection of N. Dixie Highway. As I approached the intersection, I was in the middle through lane and the traffic signal was solid red. While waiting for a green signal, I was the second vehicle back with a clear view of the intersection and traffic traveling eastbound on Yamato Rd.

I observed a white vehicle, I believed to be a VW traveling east on Yamato Rd waiting to make a left turn to head north on N. Dixie Highway. I observed this vehicle to have front end damage with the hood buckled. At this time, over the police radio, a BOLO was issued by CSO Rapa of a hit and run vehicle which just fled from a crash at 500 W. Yamato Rd. The BOLO indicated there was only a 1 minute time delay and the suspect vehicle was a white VW Jetta bearing FL tag CRHT61. The suspect vehicle was last seen eastbound on Yamato Rd. towards Dixie Highway.

The eastbound traffic began to move and the white VW which matched the description of the hit and run vehicle made a left onto N. Dixie Highway and begin to travel north. I immediately activated my overhead emergency lights and sirens to move past the vehicle in front of me and I made a right onto N. Dixie Highway. At this point I observed the white VW make a right onto Newcastle St. to head east towards N. Federal Highway. Shortly after, I also made a right onto Newcastle St. heading east. I then observed the white VW drive over the east speed bump at a higher than normal speed causing the vehicle to bounce.

The white VW then made a right onto N. Federal Highway to head south, back towards Yamato Rd. I accelerated east towards N. Federal Highway and also made a right onto N. Federal Highway. At this point, I observed the white VW, make an abrupt right turn into the parking lot of 5455 N. Federal Highway traveling west through the parking lot.


As I approached the parking lot of 5455 N. Federal Highway, I observed the white VW begin to travel south through a cut through in the adjoining parking lot. As I traveled west through the parking lot, I then observed the white VW stop the vehicle. I immediately pulled in behind the vehicle to initiate a traffic stop.

As I was exiting my vehicle a white female later identified by her FL drivers license as Meagen Wilsey exited the drivers side of the vehicle. I instructed her to remain in the vehicle, which she complied. I confirmed the FL tag of CRHT81 with dispatch over the police radio as matching the hit and run vehicle which they confirmed.

I then made contact with the driver and sole occupant of the vehicle and asked for her for her drivers license. The driver identified herself with her Florida drivers license as Meagen LeeAnn Wilsey. I then asked Wilsey for the registration and insurance for the vehicle. Wilsey began to look for the registration in the glove compartment and then stated she couldn't find it and wanted to call her friend. I instructed Wilsey she didn't need to call her friend and asked her if this was her car and she stated yes. As Wilsey spoke, her words were slurred and at times she couldn't complete her thoughts. As I spoke with Wilsey, she knew she was involved in a rear end collision.

Once Officer VanCamp and Officer Payne arrived, I turned the investigation over to them. I advised Officer VanCamp of my observations of the driver and my belief she may be impaired.






