On the above date at time I was conducting an extra patrol in the parking lot of the Homing Inn located at 2821 S. Federal hwy. It should be noted that the Homing Inn is an area well known for narcotics sales/narcotic purchases and prostitution. While driving through the parking lot I observed a Black Porsche SUV bearing Oklahoma tag AYL150 with its headlights on and occupied by one unknown driver. Due to my prior knowledge of the illegal activity at this location I decided to make a welfare check on the vehicle and its occupant.

Upon making contact with the vehicle the driver had turned the car off and opened the door and I asked for identification. Upon receiving the identification I was able to identify the driver as W/F Megan Elizabeth Gettings (09/30/1980). Gettings was asked if she had a room at this location and she informed myself that she does. Gettings was asked if she had any guns, drugs, or weapons for my safety during this encounter. Gettings stated that the vehicle and the property within belongs to her. Gettings was checked for warrants/warrants via N/FCIC/PALMS that came back with negative results. Gettings had dropped a personal item from her vehicle and I informed her of the item. As Gettings went to retrieve the item I was able to walk around the vehicle and observe through the closed passenger side window in the passenger seat an open purse. I used my flashlight to illuminate the inside of the vehicle to get a better view of what was in the vehicle and purse to check for any drugs, guns or weapons. Within the brown purse I observed in plain view a white plastic piece of what appeared to be a syringe with a slight dark residue on the plastic piece. I asked Gettings for the syringe in the purse and Gettings quickly grabbed the purse and handed me a syringe with two orange tops on both sides. Upon observation I immediately knew that Gettings was attempting to conceal the syringe by giving me a different syringe. Gettings was told to put the purse down and step outside of the vehicle and she eventually complied.

As Gettings stepped out of the vehicle she retrieved the brown purse and searched for the syringe with a white plastic piece and slightly dark residue and I was successfully able to locate the syringe that was used due to the appearance of the dark residue and blood within. I then searched for other drugs within the purse that may have been used in connection with the syringes. Inside of the purse I located a pink plastic container that read Hubba Bubba Bubble gum. Upon opening the container I observed a half empty roll of gum and 2 sets of an unknown white substance. Upon further inspection the white substance appeared to be either cocaine or heroin. I informed Gettings of my findings and placed her under arrest with handcuffs that were double locked and checked tightness. Gettings was transported to the BBPD for further processing. I tested the substance with the Scott Reagent test kit which came back positive for cocaine. The suspected cocaine weighed approximately 1.7 grams and was placed into evidence.

Based on the above investigation I have probable cause to arrest and charge W/F Megan Elizabeth Gettings (09/30/1980) with 1 count of possession of cocaine due to Gettings unlawfully and knowingly being in actual possession of cocaine. Also 1 count of possession of drug paraphernalia due to Gettings




