On the above date and time I was dispatched to 714 Lantona Avenue within the City of Lake Worth, Palm Beach County, Florida, in reference to a domestic battery. Upon my arrival to the scene, I made contact with both parties of the dispute, the male half who was identified by his Florida ID card as Mark Bates and the female half who was identified verbally as Meghan Romero, who were still verbally arguing in the roadway upon my arrival.

After I separated Mark and Meghan, I spoke with Meghan first, she stated that she just returned home from a recent hospital visit and upon her return home, her and Mark began to argue about numerous things including her recent drug use. Meghan also said that there verbal argument started to become more heated as they continued to fight. Meghan said that as she attempted to leave Mark grabbed her and punched her in the back of the head. I then spoke with Mark who stated that they did indeed have a heated fight but the argument became physical when he was attempting to break up with Meghan and she grew extremely angry. Mark said that as they were exited there house Meghan began to throw a bray of punches at his head, neck and upper torso causing him to have several bruise, cuts and red bumps on the areas just listed.

While on scene I was also able to obtain an independent witness statement from Sherrea Boothe a neighbor who was outside during this altercation. Sherrea said that she observed a white female screaming and punching a white male in the back of his head as he walked away from her. Sherrea said that the white female then grabbed the males shirt and screamed "your not going anywhere" then continued to punch him in the face.

As defined in the above investigation I placed Meghan under arrest for domestic battery against Mark.
