**Narrative:**

I was dispatched to 2202 Renaissance Way (San Raphael) in reference to a domestic disturbance. Officer Garofalo was working an off duty detail for Renaissance Commons, when he was advised of a disturbance by security. Officer Garofalo and I arrived on scene together. I made contact with a white male, later identified as Brent Rothenbusch, who stated the following:

Brent stated he was having a conversation with his girlfriend W/F Meghan Walraven, who started getting upset due to them talking about her ex-boyfriend. Brent stated Meghan became very angry and approached him in an aggressive manner. Brent stated when Meghan approached him; he attempted to walk away at which time Meghan started hitting him in the face with a closed fist. Brent stated he then grabbed Meghan by the shoulders in an attempt to stop her from hitting him. Brent stated he released Meghan and she continued to punch and scratch him.

Meghan stated her and Brent were talking about her grandfather when the argument got physical. Meghan stated she was defending herself from Brent trying to beat her. As officers were speaking with Meghan, Meghan changed her statement by stating he was trying to hold her down, not beat her.

Meghan then walked out of the apartment and contacted security, due to security being friends with both Brent and Meghan. Security in turn contacted BBPD.

I observed Brent to have a swollen left eye and numerous scratches on the left side of Brent's neck and face (pictures were taken). Brent refused medical treatment. I observed no signs of any physical injury on Meghan (pictures were taken). Brent refused to provide a sworn written statement. Brent was provided a domestic violence pamphlet and signed an exemption from public records form.

Due to the above incident, I have probable cause to charge Meghan with one count of DOMESTIC BATTERY, in accordance to FSS 784.03.(1)(A)(1). Meghan was transported to BBPD for processing and later TOT PBCJ.


