
Defendant Meza stated, " He called me a Bitch, and I slapped him in the mouth".

Camacho stated and argument started and his wife Meza slapped him once in the mouth and slapped a bowl of cereal out of his hands. Camacho advised he step back and told his wife to "back off, I'm calling the police". Camacho called 911.

Camacho stated his wife gets very violent and physical during arguments or disagreements. She has assaulted him in the past. Camacho showed a bite mark on his forearm where he alleged she took a bite out of his arm.

Base on the above aforementioned fact(s) and information, and Defendant admission to striking Camacho (husband) and Victim Camacho expressing his willingness to prosecute, Police Unit believes Probable Cause exist to charged Defendant Meilyn Fallas Meza with one count of Simple Battery (Domestic) FSS# 784.031.
