


On the above date and time I was on patrol in an unmarked PBSO vehicle in the area of 12300 Forest Hill Blvd., in the Village of Wellington, Palm Beach County, FL conducting a business check.

While I was sitting in my unmarked vehicle behind the Village of Wellington community pool I observed a group of juveniles congregating near a storage shed near the pool. I maintained visual of the juveniles as they continued to walk around the closed businesses. I observed multiple female juveniles squat behind a hedge line near the storage building and appear to urinate. The females had in their hands a clear glass bottle with an unknown liquid. I used a pair of binoculars to see if I could make out what kind of drink the female juveniles had in their hand. I was able to make out a Smirnoff label on the bottle. I observed what I thought was a Hispanic male talking with a female near my unmarked vehicle. An unknown male juvenile walked up to the two and reached into a black backpack that the Hispanic male was carrying and removed a glass bottle containing a red liquid and walk away. I then exited my vehicle wearing my PBSO Street Team uniform and approached the Hispanic male and female. The Hispanic female took off on foot yelling to the crowd, "the cops, run" discarding the black backpack. I gave chase of the Hispanic female and was able to detain him. It was determined the Hispanic male was actually a female. I escorted the female back to the pavilion where the juveniles were having a party and retrieved the discarded black backpack. The pavilion pick-nick tables were full of Smirnoff Ice bottles some empty and some were still full. Inside the bag I found two bottles of Smirnoff Ice alcoholic beverages. She was later identified as Jennifer Almaraz. I was able to detain two other females that I observed with bottles of Smirnoff alcohol in their hands. The females were later identified as Melanie Soto (01/16/00) and Marian Rodriquez (09/26/02). D/S Septien arrested Almaraz for Possession of Alcohol under 21 years of age.

Based on the above facts Probable Cause exists to arrest the Defendant Marian Rodriquez pursuant to FSS 562.111 (1) Possession of Alcohol under 21 years of age.

AFTER MAKING CONTACT WITH JENNIFER, AND SMELLING THE ODOR OF ALCOHOL ON HER BREATH, SHE SPONTANEOUSLY UTTERED THAT THE BOTTLES OF ALCOHOL WERE IN FACT HERS, AND SHE PROVIDED THE OTHER JUVENILES WITH THE ALCOHOL.

JENNIFER ALMARAZ WAS ISSUED AND SIGNED A COMPLETED NOTICE TO APPEAR, CHARGED WITH POSSESSION OF ALCOHOL UNDER 21, AND RESISTING OFFICER WITHOUT VIOLENCE PER F.S.S. 562.111(1) AND F.S.S. 843.02, AND RELEASED ON SCENE SHORTLY THEREAFTER.
