Narrative:

On February 11, 2018 at approx 0925 hrs, I responded to 1202 NW 7TH CT in reference to a domestic incident. Upon arrival, I met with W/F Melina Valenzuela who advised that she and her husband W/M Nicholas Greco got into a verbal dispute which turned physical. Valenzuela stated that around 0143 hrs on this morning they were arguing, and that she felt like Greco spit on her while they were in the dispute. She stated that she then pushed Greco back and slapped him in the face. Valenzuela said that after she slapped him, Greco kneed her on the side of the face.

I then made contact with Greco inside of the residence. Greco at first advised that they were in a verbal argument. I informed Greco that I know it turned physical at some point. Greco then advised the same story of that Valenzuela pushed him and then hit him in the face approx 7 times. Greco advised that he did not touch her or strike her back. I inform Greco that his wife would be placed under arrest for domestic battery, at which point he pleaded for her not to be arrested.

I spoke with W/F Christine Naylor who also resides at the residence. Naylor stated that when she returned home around 0700 hrs this morning she heard the two arguing. Naylor stated that shortly afterwards Valenzuela exited the room, and once she saw Naylor she began to act hurt and saying she was injured. Naylor stated that she has heard the couple be in verbal arguments but has never observed Greco strike Valenzuela.

I then returned to Valenzuela and informed her that she was being placed under arrest for one count of domestic simple battery for being the primary aggressor. Greco was provided a case card, a Domestic Violence pamphlet, and he signed the Exemption from Public Records form. I requested a master recording of the call.

The above investigation was captured on my Body Worn Camera.
