D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Sunday August 6th 2017 at approximately 04:26 hours, I was parked in the left turn lane in the 6000 block of State Road 80 in West Palm Beach Fl, 33413 conducting speed enforcement. While stationary, I observed a white Kia Forte 4 door with its hazards lights flashing and traveling west bound in the center lane at a slow speed. I observed the front passenger side of the vehicle was lower than the driver side and observed sparks underneath the vehicle. My windows were lowered and I heard a loud noise coming from the vehicle. Based on my training and experience, I recognized the vehicle to be driving on its wheel with a flat tire. I conducted a u-turn and proceeded to follow the vehicle. I observed the vehicle change lanes to the right as if it was going to exit the off ramp from southern onto Jog Rd. The vehicle then made an erupt lane change to the left back onto southern almost colliding with the concrete wall. I initiated my emergency overhead lights and conducted a traffic stop on State Road 80 (Southern BLVD) on the overpass over Jog Rd approximately in the 6500 block of SR 80. The vehicle pulled to the right shoulder and almost collided with the concrete wall. I observed the vehicle was bearing Florida tag "CZTG84". I observed the front passenger tire was flat and observed scuff marks on the wheel where the rim was making contact with the roadway.

OBSERVATION OF DRIVER:

I made a driver side approach and observed that driver who identified herself with her Florida driver's license as Melissa Katie Duralia was wearing a green skirt and a gray shirt. While questioning Duralia, I observed she seemed to be confused by my questions, and had difficulty performing tasks such as locating her registration and proof of insurance. I observed Duralia's eyes appeared red, glassy and I noticed she had a blank stare and slow speech. I observed that she was slurring her words did not understand me when speaking to her. Duralia was asked to exit the vehicle to perform field sobriety tasks which she agreed to. While exiting the vehicle, Duralia had difficulty locating her door handle and opening her door. Once her door was open she exited the vehicle and swayed heavily while standing stationary.

DRIVER'S STATEMENTS:

I asked Duralia if she had been drinking or used any drugs. Duralia stated she had several beers with her friends at Roxy's located down town. When asked if she had any medical problems and/or previous injuries, she stated none. I asked Duralia if she wore any contacts or glasses and she stated no. I asked Duralia if she takes any medication and if so what and she stated "no medication".

Obvious odor of an unknown alcoholic beverage



ROADSIDE TASKS

HORIZONTAL GAZE NYSTAGMUS: LT EYE-LACK OF SMOOTH PURSUIT RT EYE-LACK OF SMOOTH PURSUIT LT EYE-DISTINCT & SUSTAINED NYSTAGMUS AT MAX. DEVIATION RT EYE-DISTINCT & SUSTAINED NYSTAGMUS AT MAX. I escorted Duralia to the front of my patrol car where I continued my investigation for DUI. I instructed Duralia to keep her hands by her side, stand with her feet together, and follow a red light with her eyes not turning her head. I asked her if she understood my instructions. Duralia verbally stated she understood and I observed her swaying heavily not maintaining both feet together. I observed both eyes to be red, bloodshot, and glossy. Her left and right eye displayed equal pupil size, equal tracking, and a lack of smooth pursuit. I observed distinct and sustained nystagmus was present in both her left and right eye at maximum deviation during two separate four second evaluations. The onset of nystagmus was prior to a 45 degree angle in both her left and right eye during two separate four second evaluations. Vertical nystagmus was not present in both the left and right eye during two separate four second evaluations. While conducting the task, I had to remind her to keep hands by her side, not turn her head and follow the stimulus multiple times.

WALK & TURN:

I positioned Duralia on a white painted line which was well lit by the headlights on my vehicle. I instructed her to place her left foot on the line and her right foot in front of her left touching heel to toe. I instructed her that she was to keep her hands at her side and stay in this position until I instructed her to do otherwise. I instructed her to walk nine heel to toe steps counting out loud, while watching her feet. On the ninth step she was to keep her front foot on the line and use her back foot, in a series of small steps, to turn around before walking nine heel to toe steps the opposite direction counting out loud and watching her feet. I demonstrated the task, while I was verbally instructing her in the proper way to complete the task. During the task, I observed Duralia swayed while balancing, started too soon, stops walking to steady self, did not touch heel to toe, used arms to maintain balance (+6") and took incorrect number of steps.

ONE LEG STAND:

I placed Duralia with her feet together and arms at her side. I demonstrated the task as I verbally instructed her to raise one of her feet approximately six inches off of the ground, point her toe towards my vehicle, look at her raised foot, and count out loud until told to stop. I asked her if she understood the instructions and demonstration I provided. She confirmed she understood the instructions and I instructed her to start the task. While raising her foot she swayed heavily while standing in the instructional position. Duralia swayed while balancing, put foot down twice (within 30 seconds).

FINGER TO NOSE:

I instructed Duralia to stand with her feet together, make each hand into a fist keeping, extended her index fingers and to place her palms facing up. She was instructed to lower her arms to her side. I instructed and demonstrated the proper hand and arm position and for her to remain in this position while I demonstrated the rest of the task. I instructed and demonstrated to tilt her head back approximately 45 degrees and close her eyes while waiting for a verbal command of left or right. On the command of "left" or "right", she would raise the requested hand, touch the tip of her finger to the tip of her nose, then bring the hand immediately back down to her side. During the instruction and demonstration of the task she swayed heavily while standing in the instructional position. I asked her if she understood the instructions I provided and she verbally stated she understood. I instructed her to start the task as explained. During the task, I observed Duralia did not keep eyes closed, failed to return arms to side, correct finger did not touch tip of nose on both left commands and one first right command. Duralia used wrong hand.

ROMBERG ALPHABET:

I verbally inquired if Duralia could recite the entire English alphabet. She stated she was able to recite the English alphabet and I instructed her to place her feet together with her arms at her side and stay in this position until told to do otherwise. I instructed her that upon starting she was to tilt her head back approximately 45 degrees and close her eyes. She would begin to state the alphabet in a slow and methodical manner without singing or rhyming it. I asked her if she understood the instructions and she verbally replied she understood. During the instructions she continued to sway while standing stationary. I instructed her to start the task as explained. During the task, I observed the Duralia did not keep eyes closed, swayed (+2") and did not recite alphabet correctly.
