On 10/07/17 at 2014 hours, I responded to 100 E. Palmetto Park Rd (Louie Bossi), in reference to a disturbance. Upon my arrival, I met with General Manager Richard Douglas.

Douglas advised that a white female, later identified as Melissa Sontag, was acting belligerent and refused to leave the restaurant after multiple attempts to remove her by the management staff. In my presence, Douglas stated that Sontag was highly intoxicated and that he wanted Sontag removed from the property.

Officer Bruggeman and Officer Galazka attempted to have the female come outside to talk but she refused to leave the bar. Officer Bruggeman made multiple attempts to escort Sontag off of property. Sontag refused to leave after being given a trespass warning by Douglas in the presence of Officer Bruggeman.

After speaking to Douglas, I made contact with Sontag and told her to step outside so that we can talk. Sontag refused to leave and instead inquired on my age. I then told Sontag to step outside and she still refused. At that time, Officer Van Camp told Sontag that if she did not leave the property that she would be arrested. Sontag again refused to leave. At that time, I placed Sontag under arrest for trespass after warning per F.S.S. 810.08(1).

Sontag was transported to Boca Raton Police Department booking and was then processed. A written statement was submitted into evidence and an observation log was started. Sontag was then transported to county jail.
