	On 10/16/2016 at approximately 0014 hours, while on patrol at the intersection of Pulmosa Ln and Highpoint Dr. I observed a dark in color Dodge vehicle driving North on Highpoint.								
	The vehicle turned east onto Pulmosa Ln., when the vehicle east, it turned too wide and pulled into my lane of traffic almost hitting my vehicle. I turned around and continued to observe the vehicle drive east. The vehicle slowly started to drift to the left until it was driving east in the west bound lane. The vehicle continued to drift to left until it was driving off the pavement and just missing mailboxes.								
	I conducted a traffic stop on the vehicle based on the above described traffic infractions. The vehicle did not immediately stop but continued to slowly drive east for 30 seconds until it stopped on the wrong side of the road.								
	I made contact with the driver (Melissa Lucy) and immediately noticed that she appeared to be very sleepy. Her eyes were bloodshot and glassy and she was slurring her words when she spoke. I asked her for her driver's license, insurance and registration. She fumbled through her purse for 4 minutes before she found her D/L. I asked her where she was coming from. She told me that she went to the store to get a pack of cigarettes. She said she was going to her boyfriend's house two streets over but she could not tell me why she was driving on Pulmosa Ln.								
	I also noticed a strong odor of an alcoholic beverage coming from her facial area that became even stronger when she spoke. I asked Mellisa if she had anything to drink this evening and she told me that she had three beers in the last hour								
	Based on my observations i called for a DUI unit to respond to the scene to continue the investigation.								
	Inv. Levey responded to the scene and took over the DUI investigation.

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

ON 10/16/16 AT 0037 HOURS I WAS REQUESTED TO RESPOND TO A TRAFFIC STOP THAT WAS CONDUCTED BY D/S SWANSON #26674, NEAR THE INTERSECTION OF PULMOSA LN AND OLD DIXIE HWY. UPON MY ARRIVAL D/S SWANSON ADVISED ME OF THE FOLLOWING IN HIS SUPPLEMENTAL PC. "ON 10/16/2016 AT APPROXIMATELY 0014 HOURS, WHILE ON PATROL AT THE INTERSECTION OF PULMOSA LN AND HIGHPOINT DR. I OBSERVED A DARK IN COLOR DODGE VEHICLE DRIVING NORTH ON HIGHPOINT. THE VEHICLE TURNED EAST ONTO PULMOSA LN, WHEN THE VEHICLE EAST, IT TURNED TOO WIDE AND PULLED INTO MY LANE OF TRAFFIC ALMOST HITTING MY VEHICLE. I TURNED AROUND AND CONTINUED TO OBSERVE THE VEHICLE DRIVE EAST. THE VEHICLE SLOWLY STARTED TO DRIFT TO THE LEFT UNTIL IT WAS DRIVING EAST IN THE WEST BOUND LANE. THE VEHICLE CONTINUED TO DRIFT TO LEFT UNTIL IT WAS DRIVING OFF THE PAVEMENT AND JUST MISSING MAILBOXES. I CONDUCTED A TRAFFIC STOP ON THE VEHICLE BASED ON THE ABOVE DESCRIBED TRAFFIC INFRACTIONS. THE VEHICLE DID NOT IMMEDIATELY STOP BUT CONTINUED TO SLOWLY DRIVE EAST FOR 30 SECONDS UNTIL IT STOPPED ON THE WRONG SIDE OF THE ROAD. I MADE CONTACT WITH THE DRIVER (MELLISA LUCY) AND IMMEDIATELY NOTICED THAT SHE APPEARED TO BE VERY SLEEPY. HER EYES WERE BLOODSHOT AND GLASSY AND SHE WAS SLURRING HER WORDS WHEN SHE SPOKE. I ASKED HER FOR HER DRIVER'S LICENSE, INSURANCE AND REGISTRATION. SHE FUMBLING THROUGH HER PURSE FOR 4 MINUTES BEFORE SHE FOUND HER D/L. I ASKED HER WHERE SHE WAS COMING FROM. SHE TOLD ME THAT SHE WENT TO THE STORE TO GET A PACK OF CIGARETTES. SHE SAID SHE WAS GOING TO HER BOYFRIEND'S HOUSE TWO STREETS OVER BUT SHE COULD NOT TELL ME WHY SHE WAS DRIVING ON PULMOSA LN. I ALSO NOTICED A STRONG ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HER FACIAL AREA THAT BECAME EVEN STRONGER WHEN SHE SPOKE. I ASKED MELLISA IF SHE HAD ANYTHING TO DRINK THIS EVENING AND SHE TOLD ME THAT SHE HAD THREE BEERS IN THE LAST HOUR BASED ON MY OBSERVATIONS I CALLED FOR A DUI UNIT TO RESPOND TO THE SCENE TO CONTINUE THE INVESTIGATION. INV. LEVEY RESPONDED TO THE SCENE AND TOOK OVER THE DUI INVESTIGATION."

OBSERVATION OF DRIVER:

UPON MY ARRIVAL THE DRIVER WAS STILL SEATED IN THE DRIVER'S SEAT OF THE VEHICLE, AND SHE WAS THE ONLY OCCUPANT. AS I APPROACHED THE DRIVER, I INFORMED HER WHO I WAS AND ASKED IF THE DEPUTY TOLD HER WHY SHE WAS STOPPED. AS SHE ANSWERED THE QUESTION, I OBSERVED THAT HER EYES WERE BLOOD SHOT, GLASSY, AND WATERY. I ALSO OBSERVED THE OBVIOUS ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE COMING FROM HER BREATH, AND AS SHE SPOKE IT BECAME STRONGER. AS SHE SPOKE SHE ALSO SLURRED HER WORDS.

DRIVER'S STATEMENTS:

SHE STATED THAT SHE WAS TOLD WHY SHE WAS STOPPED. STATED THAT SHE WAS DRINKING. SHE SAID SHE WAS DRINKING TONIGHT. SHE ALSO SAID SHE WAS GOING TO THE STORE TO GET SOME CIGARETTES, AND THAT SHE WAS FINE TO DRIVE.

BEFORE I COULD ASK OR GIVE INSTRUCTIONS FOR ROADSIDE TASKS, SHE TOOK OFF HER SHOES, AND SAID THAT SHE HAS NEVER HAD TO DO THIS BEFORE. SHE STATED THAT SHE LIVES RIGHT AROUND THE CORNER. SHE SAID THAT SHE WILL NOT SAY THAT SHE WILL PASS BECAUSE SHE HAS BEEN GOING THOUGH A LOT LATELY.

ODORS:

OBVIOUS ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE COMING FROM HER BREATH, AND AS SHE SPOKE IT BECAME STRONGER.

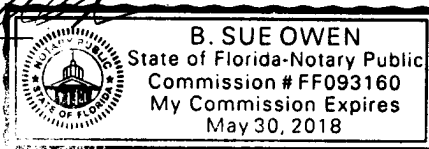

Other Observations:

The overhead forward facing blue police lights were turned off prior to beginning the task. Melissa's eyes tracked equally, the pupils were the same size and appropriate for the lighting conditions, and no resting nystagmus was observed. Vertical gaze nystagmus was administered and was not observed. Lucy had difficulty not moving her head when following the stimulus. It should be noted that several times I had to stop the task, as she lost her balance, and had to be put back into the instructional stance. At times she would sway into the wind, and others with the wind.

WALK & TURN:

I explained and demonstrated the instructions for the walk and turn task to Melissa who stated that she understood. During the task I observed that Melissa had the following cues: couldn't keep balance while listening to instructions; started too soon; stops walking to steady self/regain balance; missed heel-to-toe on all steps; stepped off the line on most steps; used arms for balance (raises arms over six inches; improper turn;

It should be noted that I attempted to have her stand in the instructional stance, however she was unable to do so, and would begin without being instructed to do so twice. She also failed to count each step as she conducted the task.

ONE LEG STAND:

I explained and demonstrated the instructions for the one leg stand task to Melissa who stated that she understood. During the task I observed that Melissa had the following cues: swayed while balancing; used arms for balance (raises arms over six inches); put foot down (before 30 seconds); could not do task (puts foot down three times). While she was attempting to do the task, she spontaneously stated "I can't fucking do that." "just take me in." This task was also conducted near the center of the roadway. I then informed Melissa that if she refused to do the roadside tasks, that she was forcing me make a decision on her behalf, and that it can be used as evidence at a later date and time. She stated that she was not refusing them. Melissa stated that she would be more comfortable doing it in a different spot. She selected a spot more on the northern side of the roadway, and was given the instructions again. During this attempt she was unable to complete the task, and fell over behind her to the floor. The tasks were then ended due to the concern of her safety.

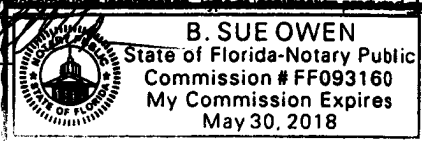

If you fail to submit to the test I have requested of you, your privilege to operate a motor vehicle will be suspended for a period of one (1) year for a first refusal, or eighteen (18) months if your privilege has been previously suspended as a result of a refusal to submit to a lawful test of your breath, urine or blood. Additionally, if you refuse to submit to the test I have requested of you and if your driving privilege has been previously suspended for a prior refusal to submit to a lawful test of your breath, urine or blood, you will be committing a misdemeanor. Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.
