On 03.15.18 at approximately 0347 hours, I arrived at 1506 North Federal Hwy # 1 in the City of Lake Worth in reference to a simple battery (domestic related) report. Upon arrival I met with victim Mr. Michael F. Prout and alleged suspect Mrs. Melissa J. Mocaj.

Mr. Prout stated that his girlfriend Mrs. Mocaj arrived home extremely intoxicated and began to punch him several times. He also stated that she also started throwing things around the house.

I then spoke with Mrs. Mocaj who appeared extremely intoxicated. She was unable to tell me what occurred tonight between her and her boyfriend however, she began to cry saying that she can not take this anymore. Mrs. Mocaj further stated that if he Mr. Prout says one more thing to her, that she was going throw something to his head.

It should be noted that I did not observe any visible injuries on Mr. Prout at the time of the investigation.

Based on the above information, I determined that probable cause exists for the arrest of Mrs. Melissa J. Mocaj for simple battery (domestic related) as per F.S.S. 784.03(1)(A)(1).
