On the 9 day of June, 2018 at 01:45 (Specifically include facts constituting cause for arrest)

On 06-09-2018 at approximately 0113 hours, I conducted a traffic stop on the driver of a silver 2001 BMW sedan (FL Tag IDFG93) by activating my overhead lights and sirens for an inoperable tag light. Upon making contact with the vehicle, the driver was identified as B/M Donlayan Rene and the passenger was identified as W/F Mercedes Rubio.

While I was explaining to Rene the reason for the stop, I could smell a strong odor of marijuana protruding from inside of the vehicle. Officer Saavedra (ID 777) and Officer Murphy (ID 751) arrived on scene and stood by with Rene and Rubio as I conducted a search of the vehicle. Officer Saavedra read Rene and Rubio their Constitutional Warnings from a pre-printed department issued card and that they were willing to speak. Upon searching the vehicle I located a small black and silver vape pen containing a brown liquid inside of the front passenger door compartment. I then met with Rubio who advised that the black and silver vape pen belonged to her and that it contained hashish oil. The brown liquid tested positive for THC by turning purple in color utilizing a marijuana quick check test kit.

Rubio was placed into custody for possession of hashish oil per F.S.S. 893.13(6A). Rubio was transported to the Boca Raton booking facility where she was processed and transported to the Palm Beach County Jail. Rene was issued a written warning per F.S.S. 316.221(2) and left the scene without further incident.
