On the above date and time, I was dispatched to the area of 17750 Rain Tree Ter, located in the Pheasant Walk Community, unincorporated Boca Raton, Forida in reference to two suspicious male subjects. Upon my arrival, I searched the area but did not locate the subjects. Another deputy radio in to say that he was conducting a traffic stop on a 4d Hyundi Elantra bearing Florida LWQM53. Inside of the vehicle were a w/f driver, Bryanna Valle and rear seat passenger, w/f Mia Grace Theodoropoulos. The vehicle was parked along the side of the roadway in a community that neither one lived nor knew anyone in. While speaking with the two, there was a strong marijuana ador emitting from within the vehicle and their person. I also observed what appeared to be a small amount of a green leafy substance on the driver's floor board. Identification was asked from the two subjects. Mia removed her identification from a medium size Louis Vuitton Purse that was position next to her in the back seat of the vehicle.

After receiving their identification, I read the two their Miranda Rights. I recovered the the green leafy substance residue from the driver's floor board and tested the substance utilizing the Naroctics Analysis Reagent Test Kit. The substance tested positive for the presence of marijuana. I continued searching through out the vehicle and while searching I observed the medium size Louis Vuitton Purse sitting on the backseat of the vehicle. The purse was wide opened and I observed what appeared to be a small plastic baggie containing a white powdery substance inside the purse. Since the purse was opened, I observed the substance in plain view. Through my law enforcement training and experience, I identified the substance as cocaine. I asked the Bryanna if this was her Louis Vuitton Purse and she stated no. She stated that the purse belongs to Mia. I recovered the small baggie from the purse and two additional baggies containing the same substance. I field test the substance from the three baggies and they tested positive for the presence of cocaine. I also found inside the purse a Chase Visa Card with the name of Mia Theodoropoulos imprinted on it. This was the same purse that Mia was in possession of when she removed her Florida Driver License from it.

I spoke with Mia and she denied ownership of the purse and the drugs.

Based on my investigation and the facts in this case, Mia Theodoropoulos was knowingly in actual or constructive possession of cocaine or ecgonine, including any stereoisomer, salt, compound, derivative or preparation of cocaine or ecgonine, a controlled substance, contrary to Florida Statute 893.13(6)(a). (3 DEG FEL) (LEVEL 3). She was arrested and handcuffs behind her back. Handcuffs were double locked for safety and checked for comfort. She was charged with 3 counts of possession of cocaine.
