SWILLEY who saw the arrested person commit the below acts.</p> <p><input checked="" type="checkbox"/> was found to have committed the below acts, resulting from my (described) investigation.</p> <p>On the <u>22</u> day of <u>September</u>, <u>2019</u> at <u>03:16</u> (Specifically include facts constituting cause for arrest.)</p> <p>The following incident occurred in the City of Delray Beach, Palm Beach County, Florida.</p> <p>On 09/22/19, while patrolling in the area of Lake Ida Rd/N Congress Ave I observed a black Nissan Sentra bearing FL tag LMAJ76 make an improper right-hand turn. I conducted a traffic stop on the vehicle. I approached the vehicle and smelled the order possible marijuana coming from the vehicle. I made contact with the driver, Alexander Schaedel (identified by FL DL), who upon requesting his driver's license, registration, and proof of insurance, pulled an round item out of his left pocket and attempted to conceal it from my view. Schaedel dropped the item between the door and driver's seat. I ordered the driver and passengers out of the vehicle, which is when the Schaedel stated the item was "rolling papers", which due to my knowledge and experience I know to be used while smoking marijuana.</p> <p>I conducted a search of the vehicle and located a gold tin containing a green leafy substance known to me to be marijuana on the driver's seat floorboard. I located a black "AWS" scale in the center console of the vehicle, which Schaedel admitted was his post Miranda. Numerous plastic bags and white envelopes with numbers on them were on the floorboard and center console. I located a box in the trunk of the vehicle containing multiple clear plastic containers with a green leafy substance inside, which I also believed to be marijuana. The marijuana later tested positive for a reaction to THC utilizing a field test kit weighing 27.2 grams with packaging. Post Miranda Schaedel stated the green leafy substance was marijuana.</p> <p>While conducting my search of the vehicle Ofc. Bolanos was advised by Teletype that the front passenger of the vehicle, Micah Geraci-Wahlin, had active warrants in Palm Beach County for Failure to Appear (19 002049). Ofc. Bolanos asked Geraci-Wahlin if she had any illegal items on her person prior to being placed in handcuffs. Ofc. Bolanos stated that Geraci-Wahlin looked down at her waist, which is when he ordered her to hand the</p>
