I was patrolling the 300 block of 15th Avenue South, within the city of Lake Worth, Florida 33460, in marked PBSO vehicle # 78212. At 0416 hours, I saw a gray Suzuki SX4, bearing New Jersey tag J43CFH, stopped in the middle of the westbound lane of 15th Avenue South, facing westbound.

A black male, identified verbally as Scottie L. Martin and a white female, identified verbally as Leah T. Coyne, entered the vehicle, which did not have the front headlights on. Upon sight of my marked PBSO vehicle, the Suzuki began traveling westbound on 15th Avenue South. The vehicle still failed to activate the front headlights, as it approached South Dixie Highway. As I got behind the vehicle, I also noticed that the tag light was not functioning.

I conducted a traffic stop on the vehicle and we came to a final stop in the 1400 block of South L Street. As the vehicle stopped, Ms. Coyne exited the rear passenger compartment and began walking westbound. I gave a verbal command for Ms. Coyne to get back into the vehicle, which she complied with.

I made contact with the driver, who was identified by his valid New Jersey driver's license as Michael A. Valenzano. After identifying myself and the reason for the traffic stop, I noticed that Mr. Valenzano began sweating profusely. He began shaking his hands and breathing heavily. I looked in the front driver side window, which was completely rolled down. I saw several small white pieces of a white substance, which I immediately identified as crack cocaine, through my training, knowledge and experience as a law enforcement deputy with the Palm Beach County Sheriff's Office. I read Miranda warnings to Mr. Valenzano, from an issued Miranda warning card, on camera.

As I conducted a records check of Mr. Valenzano's vehicle, dispatch told me that it was not registered, even after conducting a records check of the tag and vehicle identification number. I asked Mr. Valenzano if he could exit the vehicle, which he complied. As Mr. Valenzano exited the vehicle, I saw a glass cylinder with residue, which I immediately identified as a crack pipe, sitting on the driver's seat, directly under Mr. Valenzano's buttocks.

I placed handcuffs on Mr. Valenzano's wrists, which were checked for proper fit and double locked for safety. As I began searching Mr. Valenzano, he told me that he had crack cocaine in the front left pocket

of his shorts. During my search, I ~~located the cocaine~~ ^{found 43 grams} cocaine in his pocket. Mr. Valenzano then told me that the crack cocaine must have fallen out of his pocket and onto the floor of his vehicle. Mr. Valenzano also told me that he keeps crack cocaine in the front driver's door panel.

I searched Mr. Valenzano's vehicle, in search of the crack cocaine he said fell out of his pocket. I located (2) small white rock like substances on the floorboard of Mr. Valenzano's vehicle. I also found a medium sized white rock like substance inside the driver's door panel, along with the original white substance I saw in plain view through the open window. Each substance tested positive for cocaine from an issued Cobalt reagent test kit.

Along with the glass crack pipe with residue that Mr. Valenzano was sitting on, I located a second glass crack pipe with residue on the floorboard of the driver's side.

Mr. Valenzano told me that he has a drug problem and he is trying to get better. He told me that he smoked crack cocaine earlier this morning.

Based on my investigation, physical evidence and statements, I found Mr. Valenzano to be in violation of FSS 893.13(6)(A), because he was knowingly in actual or constructive possession of cocaine or ecgonine, including any stereoisomer, salt, compound, derivative or preparation of cocaine or ecgonine, a controlled substance.

I also found Mr. Valenzano to be in violation of FSS 893.147(1), because he did use or possess with intent to use (2) glass crack pipes with residue, drug paraphernalia, for injecting, ingesting, inhaling, or otherwise introducing into the human body a controlled substance.
