The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law... On the 7 day of February 20 18 at 11:23 A.M

I responded to a code green (Disorderly Disturbance) in the blood draw clinic on the first floor. Upon my arrival I observed Michael Nelsen (subject) standing nose to nose with Ameldia Durette (victim) yelling obscenities. Durette had her back to the wall and Nelsen was in front of her.

I stated twice for Nelsen to move back twice the I had to physically separate Nelsen and requested for him to stand back and stand down. Nelsen stood in spot where I had to physically place him but continued to call Durette a "cunt and a fucking bitch." I asked one of the West Palm Beach Code Green staff to take Nelsen to the other room. Cpl. Montesino came a backup and was asked to talk to Nelsen.

Cpl. Montesino walked up to Nelsen identified himself as "Cpl. Montesino VA Police" "I need to see your identification." Nelsen Replied "no." Nelsen was taken in to custody for failure to identify himself. Nelsen also was taken in to custody for disorderly conduct and simple assault. Durette wrote a statement that stated, "she felt like Nelsen was going to hurt her." Durette also stated in her statement that she "was glad that the police came to get him out of her space"

Durette requested to press charges subsequently Nelsen will be charged with FSS:784.011(1) Simple Assault, Disorderly Conduct FSS: 877.03, Resisting without Violence FSS: 843.02.
