WHILE THE 911 CALL CAME IN, ANOTHER MAINTENANCE WORKER, MICHAEL GENTILE, HEARD AND SAW THE FEMALE SCREAMING "PLEASE HELP ME, MY HUSBAND IS GONNA KILL ME!" MR. GENTILE RAN TO THE NORTH GATE OF THE POLICE DEPARTMENT, WHERE HE ADVISED DETECTIVE SERGEANT TODD GROSSMAN AND DETECTIVE MITCHELL CONNERTON OF THE WHAT WAS HAPPENING.

THEY IMMEDIATELY RESPONDED TO THE APARTMENT AND LOCATED THE FEMALE, TIFFANY TESAURO, SITTING ON A BENCH AT THE BOTTOM OF THE STAIRS. SHE WAS VISIBLY UPSET, CRYING AND TRYING TO CATCH HER BREATH. TESAURO HAD RED MARKS ON THE RIGHT AND LEFT SIDE OF HER NECK AND A FOUR INCH ABRASION ON HER LEFT THIGH AREA. TESAURO REFUSED MEDICAL TREATMENT.

THE MALE HALF, LATER IDENTIFIED AS, MICHAEL ANTHONY PASCARELLA, HAD ALREADY LEFT ON A BICYCLE, WEARING WHITE/GRAY BACK PACK, A RED/WHITE SHIRT AND BLACK PANTS. SERGEANT BUNTIN AND COOPER LOCATED PASCARELLA ABOUT A HALF A MILE AWAY, ON THE SIDEWALK, IN FRONT OF PALM BEACH ORTHOPEDIC CENTER, 4215 BURNS ROAD, PALM BEACH GARDENS. HE HAD ABRASION ON HIS CHEEK, HIS LIP AND A BITE MARK ON HIS LEFT FOREARM. HE ALSO REFUSED MEDICAL TREATMENT, THEREFORE, PARAMEDICS WERE NOT CALLED.

BOTH PARTIES STATED THEY WERE ARGUING ABOUT PASCARELLA WATCHING PORN. TESAURO ALSO SAID WAS LOOKING UP ABOUT SUBUTEX PILLS AND THAT HE HAD TRIED TO LOOK UP HIS EX-GIRLFRIEND. THE COUPLE HAS BEEN TOGETHER 1 1/2 YEARS AND GOT MARRIED JUNE 2017.

LAST NIGHT TESAURO FOUND THE EX-GIRLFRIENDS NAME AND PORN SITES THAT HE VISITED ON HIS PHONE AND WOKE HIM UP AT 1:00 A.M. QUESTIONING ABOUT WHAT SHE FOUND. HE DID NOT ANSWER HER AND FELL BACK TO SLEEP. WHEN HE JOINED HER IN THE SHOWER THIS MORNING, SHE WAS QUIET AND HE ASKED HER WHY SHE WAS QUIET AND THAT STARTED THE ARGUMENT.

POST MIRANDA, TESAURO, STATED THAT HER HUSBAND GRABBED HER BY THE THROAT AND PUT HER UP AGAINST THE SHOWER WALL. TESAURO DID NOT FIGHT BACK AT THAT MOMENT AND PASCARELLA LET GO OF HER AND YELLED FOR HER TO GET OUT. HE ALSO YELLED FOR HER TO LEAVE THE HOUSE.

TESAURO SAID SHE WENT TO THE BEDROOM TO GET HER CLOTHES AND PASCARELLA CAME BUSTING IN THE BEDROOM DOOR. THE DOOR FRAME WAS ALREADY BROKEN FROM PAST INCIDENTS, SO NOW IT WAS PARTIALLY HANGING OFF.

TESAURO STATED THAT THE ARGUING CONTINUED IN THE BEDROOM AND HER HUSBAND ATTACKED HER WHEN SHE TRIED TO DIAL 911. SHE SAID THE INITIAL 911 CALL DID NOT GO THROUGH AND WHEN THE SECOND ATTEMPT DID DIAL, PASCARELLA GRABBED HER PHONE AND THREW IT AT A VANITY DRESSER, BREAKING THE GLASS ON THE MIRROR AND THE PHONE. I CHECKED WITH DISPATCH, WHO NEVER RECEIVED THE 911 CONNECTION.

TESAURO SAID RIGHT AFTER HE THREW THE PHONE, HE SHOVED HER TOWARDS THE SLIDING GLASS DOORS, WHICH BENT THE METAL FRAME ON THE DOOR. TESAURO SAID SHE SAW THAT THERE WERE PEOPLE OUTSIDE AND TRIED TO OPEN THE SLIDER DOOR, BUT IT WOULDNT OPEN SO SHE SCREAMED FOR HELP.

THIS IS WHEN WITNESSES, GENTILE AND CABRERA, HEARD TESAURO SCREAM "PLEASE HELP ME, MY HUSBAND GONNA KILL ME!" AND SAW HER TRYING TO GET OUT THE SLIDER DOOR. GENTILE THEN SAW THAT SHE WAS BEING PULLED BACK BUT COULD NOT SEE WHO IT WAS, BUT CABRERA SAW THE HUSBAND, PASCARELLA GRABBING HER BY SHOULDERS AND THROW HER FORCEFULLY TO THE FLOOR.

TESAURO SAID AFTER HE THREW HER TO THE FLOOR, HE GRABBED HER BY HER THROAT, WITH BOTH HANDS AND CHOKED HER

HARDER THAN HE HAS EVER DONE BEFORE. TESAURO THOUGHT SHE WAS GOING TO DIE, SO SHE FOUGHT FOR HER LIFE. SHE SAID SHE PUNCHED HIM IN THE FACE AND FORCED HIM OFF OF HER.

ONCE SHE GOT HIM UP OFF OF HER, SHE SAID SHE PUSHED HIM ONTO THE BED AND HE TRIED TO ATTACK HER AGAIN AND SHE BIT HIM IN HIS ARM. WHEN TESAURO TRIED TO RUN OUT OF THE BEDROOM, THE DOOR WAS STILL HANGING ON ONE HINGE AND SHE KNOCKED IT DOWN ON TO THE FLOOR, FALLING WITH IT AND GOT BACK UP AS SHE RAN OUT OF THE APARTMENT.

AS TESAURO RAN DOWN THE TWO FLIGHTS OF STAIRS SHE CONTINUED TO SCREAM FOR HELP AND COLLAPSED TO THE GROUND AT THE BOTTOM OF THE STAIRS. THIS IS WHEN THE NEIGHBOR, FREDERICK MIMS, WHO RESIDES ACROSS THE HALL FROM THEM, WHO WAS SITTING IN HIS BACK BEDROOM AND HEARD A FEMALE SCREAMING FOR HELP. HE SAW TESAURO, LYING IN A FETAL POSITION AT THE BOTTOM OF THE STAIRS.

MIMS SAID SHE WAS TRYING TO CATCH HER BREATH BUT IT TOOK AWHILE. WHILE MIMS WAS ATTENDING TO TESAURO BY GETTING HER A BLANKET, TESAURO'S HUSBAND CAME DOWN AND CURSED AT HER. MIMS STOOD BETWEEN BOTH SUBJECTS. PASCARELLA LEFT ON HIS BIKE WHEN MIMS CALLED 911.

PASCARELLA STATED TO SERGEANTS BUNTIN AND COOPER THAT WHILE HE WAS TAKING A SHOWER, HIS WIFE CONFRONTED HIM ABOUT WATCHING PORN. HE STATED HE WASNT GOING TO ARGUE ABOUT THIS AND GOT OUT AND WENT INTO THE BEDROOM TO GET DRESSED FOR WORK. AS HE WAS PUTTING ON HIS PANTS SHE CAME AT HIM, SO HE RAISE HIS LEFT ARM. THIS IS WHEN SHE BIT HIM.

PASCARELLA THEN RAISED HIS OTHER ARM TO GET HER OFF OF HIM AND THIS IS WHEN SHE SWUNG AT HIM HITTING HIM IN THE JAW. PASCARELLA THEN EXITS THE BEDROOM TO PUT ON HIS SHIRT AND SHE KICKS THE DOOR DOWN. PASCARELLA SAID "WHAT THE FUCK!" AND SHE RUNS OUT OF THE HOUSE AND YELLS "CALL 911!" PASCARELLA GRABS HIS BIKE AND LEAVES.

BASED UPON MY DESCRIBED INVESTIGATION, PASCARELLA IS CHARGED WITH BATTERY BY STRANGULATION (DOMESTIC VIOLENCE RELATED), CONTRARY TO F.S.S. 784.041 (2) (A).

DURING THIS INVESTIGATION, BODY WORN CAMERAS WERE UTILIZED. THEY ARE DOWNLOADED TO EVIDENCE.COM.
