


### NARRATIVE:

On Friday, August 4, 2017 at 1450 I was on routine patrol in the Palm Beach International Airport, 3200 Belvedere Road West Palm Beach, FL 33406, in C terminal when I began receiving reports from patrons regarding a white male subject possibly stealing merchandise from the gift shop at this location. Upon further investigation, the male subject was located and identified as Defendant Michael Castagna. Castagna admitted to me that he had taken three items from the store and gave them back to me. I learned from store management that they did not wish to press charges and were satisfied with the return of their property. Refer to PBSO case number 17-110748 for details regarding the retail theft investigation. Castagne was advised to calmly wait for his flight and was asked not to disturb the patrons or local business during his wait. Castagne appeared to understand my instructions though his behavior was unusual and there appeared to be a possibility that he was intoxicated or under the influence of some other unknown substance. Castagne initially sat down near his corresponding gate but soon after walked away acting erratically and leaving his bag behind. Customers began approaching me concerned for their safety and inquiring what flight Castagna was waiting for in case it was the same as theirs. I made contact with Castagna again and advised him he needed to stay with his bag. Castagna became increasingly agitated and was making senseless remarks to me. Jet Blue representatives also became concerned about Castagna's behavior and whether he could fly with Jet Blue. As they spoke to him and offered to place him on a later flight, Castagna became belligerent with Jet Blue representatives. The representatives continued to attempt to accommodate him but Castagna would yell over them and would not listen. When I attempted to calm him down, Castagna yelled at me as well and refused to desist from this disruptive behavior. Due to Castagna's behavior disrupting the airlines and local businesses, as well as the disturbance to the general public and his refusal to desist from the disruptive behavior, Castagna was placed under arrest for disorderly conduct. Castagna was later transported to PBSO county jail without further incident.
