On 06/23/18 at 2106 hours, I was dispatched to 1325 N Federal Hwy (Frog Lounge) in reference to a disturbance. I made contact with Michael Naccarato who was causing a disturbance at this location. Patrons were coming outside of the business and starting to gather focusing their attention on Naccarato. Naccarato was stumbling and slurring his words in the parking lot of this business. Naccarato could not unlock his bike and needed assistance from a bystander at the business. I advised Naccarato that he could not ride his bike home because he was too intoxicated and he agreed. Naccarato attempted to call and uber but could not function the app. While this was going on Naccarato became verbally abusive and aggressive toward officers and was having trouble communicating. Naccarato was asked multiple times to calm down and lower his voice but he continued to cause a disturbance.

Based on the following facts, probable cause exists to arrest Michael Naccarato for Disorderly Intoxication FSS 856.011.
