 On the **14TH** day of **JANUARY** 20**18** at **4:23**  A.M.  P.M. (Specifically include facts constituting cause for arrest.)

On Sunday, January 14, 2018 at approximately 0332 hours, while patrolling the area of S Military Trl and Palm Ave, I observed a white female going back and forth on S Military Trl with a white male following her. I then made contact with both subjects who appeared to be arguing. While attempting to speak with the female subject, who was verbally identified as Vanessa Nobile, attempted to explain what was going on, however the white male who was verbally identified as Michael Guarneri, continuously interrupted her by yelling and screaming at her.

Upon the arrival of D/S Blackman ID# 8386, Guarneri and Nobile were separated and I was able to speak with Nobile. Nobile informed me that she was trying to leave Guarneri by walking away, however he continued following her, yelling at her, and would not stop when she told him to. Nobile stated that Guarneri blocked her path and would not let her leave. Nobile advised she was pregnant with Guarneri's child and they've been boyfriend and girlfriend for five months. While speaking to Nobile, Guarneri kept yelling at Nobile, stated that she was not leaving and she needed to go to his father's house with him. Nobile informed me that she wished to leave and go back to Boynton Beach. After the FCIC/NCIC check of Nobile came back clear, she was allowed to leave the scene in order to be separated from Guarneri.

While speaking with Guarneri, he confirmed that Nobile was pregnant with his child. He stated that he was not going to let her return to Boynton Beach after he was told that Nobile was an adult and could leave when she wanted. Guarneri was informed to go back to his father's house and leave Nobile alone. After the FCIC/NCIC check of Guarneri came back clear, he was released on the scene, at which time he was observed running after Nobile. I observed Guarneri catch up to Nobile and grabbed her and Nobile pulled away from him. I then proceeded to follow Guarneri to the location where he dragged Nobile into the parking lot of TD Bank located at 1031 S Military Trl in West Palm Beach. As I entered the parking lot, I observed Guarneri holding onto Nobile, who was trying to pull away from him. While observing the patrol car entering the parking lot, Guarneri released Nobile's arm, turned around and attempted to walk away.

Based on my observation and Nobile's statement, there was probable cause for the arrest of Michael Guarneri for Simple Battery Domestic Violence related contrary to F.S.S.
