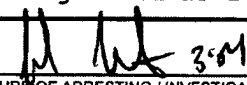

P R O B A B L E C A U S E	On 12-9-19 at approximately 2207 hours, I was dispatched to 129 Soundings Ave. Jupiter, FL 33458 (The Woods), in reference to an intoxicated male causing a disturbance. Upon my arrival, I made contact with the complainant, Josh Young (W/M 4-13-98), who is the on-site security guard.									
	Young advised that an intoxicated male, later identified as Michael Holenko (W/M 12-12-85), was asked to leave the property and a Lyft was ordered for him. As the Lyft driver arrived, he continued past the pickup point due to observing Holenko flailing his arms around in an aggressive manner. Young advised that he asked the Lyft driver to return and pick Holenko up as appeared to have calmed down. When the Lyft approached, Holenko refused to enter the vehicle, stating that was not his ride. The Lyft driver then drove off and Young contacted the Police.									
	I made contact with Holenko, who was outside of the establishment, sitting on a bench. Holenko smelled of an unknown alcoholic beverage, had urinated in his pants and was slurring his speech. I asked him to either call a friend or order a ride through Uber or Lyft, in order to be picked up from the property as his friends had left him there. He stated to me that he was "going to call for a blow job". I again asked him to call for a ride and he advised that he would call his girlfriend. He made multiple attempts to call a friend in which no one answered his call. I then asked him if he uses Uber or Lyft. He stated that he can't use Uber because he was banned from using Uber due to fighting with a previous driver. He advised that he did have the Lyft application and would order a Lyft. He showed me that the transaction was complete and did in fact order a ride and would arrive in approximately ten minutes.									
S T A T E M E N T	As I was standing by to ensure he was picked up, he continued to get up from the bench and would stumble each time. I asked Holenko to stay seated so that he did not fall and injure himself. He continued to get up and began to get agitated as I would ask him to

sit back down. He eventually became confrontational with myself and Officer Pope. At one point he began aggressively walking towards Officer Pope shouting that he was not "scared of us" and started yelling to Officer Pope to "challenge him" in an aggressive manner by walking through a patch of landscaping at him, with his arms tense and his chest bowed out. He stopped approximately an inch away from Officer Pope, and at that time I walked behind Holenko and placed him into custody. Based upon my above investigation, I found that Michael Holenko was intoxicated and endangered the safety of another person or property, or was intoxicated or drank an alcoholic beverage in a public place or in or upon a public conveyance and caused a public disturbance, contrary to Florida Statute 856.011(1). I advised Holenko that he was under arrest for disorderly intoxication and I placed him into handcuffs, checked for proper spacing and double locked them. Holenko was subsequently transported to Palm Beach County Jail without incident. I utilized my Axon body worn camera for this call for service.
