Ofc.Salvemini then turned Michael over to me and told me the following.</p> <p>Square Grouper security, Mike Frederick, stopped Berthiaume from exiting the restaurant because Berthiaume had a cup with what appeared to be water in his hand. There is a restaurant policy, and Town Ordinance, that forbids bar patrons from exiting an establishment with any type of beverage or open cup.</p> <p>Frederick explained this to Berthiaume, who then became argumentative. Ofc.Salvemini heard the argument and walked over to the two. Ofc.Salvemini then asked Berthiaume to go back into the establishment and finish his beverage or leave it inside before exiting. Berthiaume went back inside the establishment. After sometime, Ofc.Salvemini, saw Berthiaume running out of the establishment with the same beverage in hand.</p> <p>Ofc.Salvemini, stopped Berthiaume and took the beverage away from him and placed it on a nearby bench. Ofc.Salvemini again explained that Berthiaume cannot take a beverage outside of the establishment. Berthiaume got argumentative with Ofc.Salvemini. Ofc.Salvemini gave Berthiaume a trespass warning of 1 year per management and Frederik.</p> <p>Berthiaume got upset and continued to argue with Ofc.Salvemini. Ofc.Salvemini instructed Berthiaume multiple times to leave the property or he would be arrested. Berthiaume refused to leave the property. Berthiaume then stated that his rights were being violated and no one can tell him what he can or can't do.</p>
