## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

At approximately 01:07hrs I responded to a report of a suspicious vehicle which was parked in the grass swail in the 14400 block of Greenbriar Blvd which is located in the Village of Wellington, Palm Beach County. I arrived on scene at 01:16hrs and observed a white 2017 Chevy Malibu bearing Florida tag GHV-K86 running with the car in gear. The Chevy was missing the front left tire and had pieces of bushes in the front grill. The Chevy was occupied by a W/M who was passed out behind the wheel.

### OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified as "MICHAEL KELLY" by his passport from Ireland, I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from his person and face area. Kelly was sleeping in the driver seat of the Chevy and was the sole occupant. Kelley was drooling down the front of his shirt and was unresponsive to several sternum rubs. Finally after getting Kelly to wake, he was extremely disoriented. In removing Kelly from the vehicle, the odor of the unknown alcoholic beverage intensified as I spoke to him. Kelly had extremely glassy, glazed, and blood shot eyes. His speech was slurred, slow, and thick, and at times difficult to understand with an Irish accent. Kelly's movements were slow and deliberate. Kelly was lethargic in his movements with poor coordination. Kelly had an unsteady gait while walking to my patrol vehicle.

### DRIVER'S STATEMENTS:

Post Miranda admissions from Kelly while on scene were he had only consumed 1 glass of wine while at dinner with friends. Admissions at the BAT were he had consumed 5 or 6 beers and was operating the vehicle.

### ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from Kelly person and face area which intensified as I spoke to them.

## GENERAL OBSERVATIONS

SPEECH: Kelly's speech was slurred, slow, and thick, and at times difficult to understand.

ATTITUDE: ~Sleepy, polite, friendly, cooperative, and apologetic

CLOTHING: blue vest / blue striped shirt / blue jeans / orange & blue sneakers



## ROADSIDE TASKS

Other Observations:

Kelly would sway roughly in a side to side front to back pattern throughout the task. Kelly did not touch the tip of the pen as directed to positively identify the point to be tracked. He touched the left side of the pen and dragged his hand up the tip. Kelly was reminded numerous times to track the pen with his eyes only. He failed to keep his head still while tracking the stimulus. Kelly was instructed to hold his chin with his left hand and his left elbow with his right hand to further stabilize his head and keep it from moving.

WALK & TURN:

I explained and demonstrated the instructions for the "Walk & Turn" to Kelly who stated the he understood. Kelly would sway roughly in a side to side, front to back pattern throughout the demonstration phase. Kelly could not maintain his balance while listening to instructions and stepped out of the stance during the demonstration. Kelly started the task before being instructed to do so. Kelly had pauses to regain his balance. Kelly, on the first pass missed heel-to-toe steps and stepped off the line, using his arms for balance. Kelly performed the turn other than the way it was demonstrated. On the return, he would miss heel-to-toe steps and stepped off the line. Additionally, Kelly performed the incorrect number of steps of 8 on the first pass and 10 steps on the return. Kelly was asked how many steps he was told to take and he responded by saying "9". When asked why he took the the incorrect number of steps he had no reply.

ONE LEG STAND:

I explained and demonstrated the instructions for the "One Leg Stand" to Kelly who stated that he understood. He would sway roughly in a side to side, front to back pattern throughout the demonstration phase. He continued to sway while balancing on one leg. Kelly used his arms to balance raising them more than 6 inches from his sides. Kelly put his foot down at 1, 8, 12, & 20 seconds to regain his balance before the 30 seconds had elapsed.

FINGER TO NOSE:

I explained and demonstrated the instructions for the "Finger to Nose" task to Kelly who stated that he understood. He would sway roughly in a side to side, front to back pattern throughout the demonstration phase. He did not keep his eyes closed and had to be reminded numerous times. Kelly failed to return his arm down to his side as instructed after touching his nose. Kelly's index finger did not touch the tip of his nose on 4 of the 6 attempts. Kelly hesitated & searched for the tip of his nose prior to touching the tip. The sequence used for this task was L, R, L, R, R, L.

ROMBERG ALPHABET:

I explained and demonstrated the instructions for the "Rhomberg Alphabet" task to Kelly who stated that he understood. He would sway roughly in a side to side, front to back pattern throughout the demonstration phase. Kelly incorrectly recited the alphabet twice. Kelly recited "A" through "V" then stated "G, U, V G, Z, X, Y" then restarted correctly to "V" then stopped and laughed.


