

	On 5/30/2018 at 10:09 p.m. I was dispatched to 7855 Woodsmuir Dr, Palm Beach Gardens, Palm Beach County, Florida, reference to a disturbance call. My BWC was used during this entire event.					
P R O B A B L E C A U S E	Upon arrival I made contact outside with a female, later verbally identified to be Susan Morgan. Morgan was crying and upset. Morgan stated that her boyfriend, later identified by his Florida Driver's License to be Michael Talanian, was mad at her and acting aggressive. Morgan stated that he was yelling and punching the walls, because of a phone call that Morgan took from Talanian's business partner ("Joel") in Atlanta. Morgan stated that at no time did she or Talanian have any physical altercation. Morgan stated that at the time of the disturbance she was afraid of Talanian but did not believe he would harm her.					
	Myself, Officer Dorow (ID 483), and Officer Witt (ID 492) then made entry into the residence to speak with Talanian. Talanian was inside of the master bedroom, which is located on the North side of the house. Talanian was given commands to exit the room, which he complied. As I began to speak with Talanian, Officer Dorow checked the master bedroom to do a protective sweep of the area. Officer Dorow then asked me to step into the room with him, while Officer Witt stayed with Talanian. Officer Dorow led me down a hallway, to a small walk-in closet with a gun safe in it, where multiple glass pipes, along with a white rock like substance was found on a shelf in the closet, in plain view. I then returned to Talanian to ask him questions reference to his disturbance with Morgan.					
	Talanian told me that Morgan answered a phone call of his, earlier in the evening. Talanian stated that he missed a business flight, and the phone call was from his business partner. Talanian stated that Morgan told his business partner that Talanian missed the flight, which upset Talanian. Talanian stated that he did yell at Morgan but

<p>did not have any type of physical altercation with Morgan. It should be noted that neither Morgan nor Talanian showed any visible signs of injury or bruising to either of their persons.</p> <p>I then spoke with Morgan again, outside. I read Morgan her Miranda Warnings from a department issued card. Morgan stated she understood her rights and was willing to answer my questions. I then asked Morgan, who's house it was and she responded "Michael's". I asked Morgan if she was aware of the walk-in closet in the master bedroom with the gun safe in it, and she replied "yes". I then asked Morgan if she new what the white rock like substance was on the shelf, and she replied, "it's Michael's". When I asked Morgan if she has ever seen Michael (Talanian) use the substance, she told me she doesn't know, and that Michael goes in that closet to "whatever".</p> <p>I then spoke with Talanian again. I read Talanian his Miranda Warnings from a department issued card. Talanian advised he understood his rights and would answer my questions. I asked Talanian who's room the master bedroom was, and he replied "mine". I asked Talanian if he was aware of the small walk-in closet with the gun safe in it, and he stated he was. I then asked Talanian what the white rock like substance was on the shelf in that closet, and he responded cocaine, and marijuana. I asked Talanian who's cocaine and marijuana it was, and he responded "mine".</p> <p>Talanian was placed in handcuffs, which were checked for tightness and double locked. Officer Dorow then asked Talanian if there was any other illegal contraband inside of the residence, which Talanian stated yes, inside the safe. Talanian advised the combination of his safe, and we proceeded to the closet. Inside of the safe was more of the white rock like substance, a green leafy substance, and multiple prescription pills, all of which Talanian advised he had no prescription for.</p> <p>Officer Dorow collect all of the contraband, which was subsequently entered in evidence. The items collected were as follows: 3 Oxycodone pills, 4 Xanax pills, 2.5 grams of suspected crack cocaine, 6.9 grams of suspected marijuana, 21 glass pipes, 1 cylindrical grinder, commonly used to break down marijuana, and 1 digital scale, which is commonly used to weight narcotics.</p> <p>Talanian was then transported to the Palm Beach Gardens Police Department for further processing, then transported to the Palm Beach County Jail.</p> <p>Based on my investigation and the statements of the parties involved, Michael Talanian is being charged with one count of Possession of Cocaine for violating F.S.S. 893.13, one count of Possession of Marijuana under 20 grams for violating F.S.S. 893.13(6) (B), one count of Possession of a controlled substance without a prescription (Xanax) for violating F.S.S. 893.13(6) (A), one count of Possession of a controlled substance without a prescription (Oxycodone) for violating F.S.S. 893.13(6) (A), and one count of</p>
