On 3/15/18 at 2131 hours I responded to 561 NE 47th St in reference to a domestic disturbance. Upon my arrival I made contact with W/M Michael Pagel who was outside of his residence. Shortly after I made contact with Michael, his wife Gladys Pagel, approached me in her vehicle.

Gladys advised that she was talking on the phone with her sister when her husband Michael grabbed her cell phone from her right hand. It should be noted that there was no physical contact with Michael when he grabbed her cell phone. Gladys stated she then began pleading with Michael to get him to give her back her phone but he refused. Gladys eventually grabbed Michael's phone from his back right pocket which did not involve any physical contact with Michael. Michael and Gladys continued arguing and both of them eventually ended up upstairs in a hallway. Gladys stated that she was just standing in Michael's way when he grabbed her with both of his hands in her upper arms and shoved her out of his way. Michael and Gladys then both went outside to the driveway and Michael held Gladys phone above his head. Gladys made several attempts to grab it from his hand by jumping and reaching for it but on one attempt missed and accidentally knocked his glasses off of his face with one of her hands. Gladys advised that the contact was purely accidental and incidental to her trying to grab her phone back from Michael. Gladys advised that she helped Michael by picking up his glasses and giving them back to him.

Michael advised that he did not grab her phone from her when she was talking to her sister but only when she was holding it in her hand. Michael advised that he did not make contact with her hand. Michael confirmed that Gladys took his phone from him without any contact. Michael confessed that in the hallway upstairs he intentionally moved Gladys out of the way by grabbing her with both of his hands. Michael advised that Gladys struck him in the face with her hand which caused his glasses to get knocked off of his face.

I observed redness on both of the upper arms of Gladys. I did not observe any visible injuries on Michael. Based on the height difference between Gladys (5'02) and Michael (6'1), I concluded that Gladys account of accidentally knocking off Michael's glasses while reaching for her cell phone which Michael was holding over his head can be classified as incidental contact that was not intentional. Michael on the other hand admitted that he intentionally grabbed and shoved Gladys out of his way.


Based on the results of my investigation, I placed Michael Pagel under arrest for Domestic Battery pursuant to F.S.S. 784.03(1A1). Michael was TOT PBCJ. Officer Reissi advised that Gladys refused to provide a written statement or consent to us taking pictures of her injuries. Officer Reissi provided Gladys with a domestic violence victims' rights pamphlet.
