
I am assigned to a national task force known as the South Florida Internet Crimes Against Children (ICAC). This task force investigates internet crimes against children, child exploitation, and related cases.

On June 9, 2018, I was in an undercover capacity attempting to locate and identify offenders that use the internet to sexually exploit children.

On June 9, 2018, the suspect, 33-year old Michael messaged me on a chatting application. Michael indicated that he was a 33-year-old male who lived in West Palm Beach, Florida.

The following conversation was over a period of two weeks. The following is a brief dialog of the text message thread. In responding to the message, he sent "Heyy," I replied "Hi." Michael later messaged "Text me 561-452-4824." I began the text message conversation with Michael using the telephone number he provided. I text messaged Michael that I was "fithteen." He replied, "Dang I'm 33." Michael asked, "You have sex yet." I replied, "No, I'm a virgin." Michael replied, "I can wait 3 years." I replied "Ok." Michael replied, "Send me a pic sexy." Later in the conversation, Michael stated, "I will give you the dick if you want that to." I replied, "condoms?" A few text messages later, Michael stated, "Going to make you come every where." I replied, "tell me how, details." Michael replied, "First I'm gonna fucking rip off you panties, then going to finger you, and I'm a lick your pussy. After that when you get loosened up im going to ram my dick in there." I replied, "Oh my." Then I stated, "You said you're going to wait 3 years when I'm 18..." Michael replied "Naw, Fuck it." Several text messages later, Michael asked "we going to fuck, lol." I replied "I thought that's what you said earlier lol." Later, Michael stated "Cant Wait, I'm horny you want to see lol." I replied "me too." A few text messages later, Michael sent a picture of a male sitting on furniture, holding a penis in the right hand, while inside a house. Michael later confirmed that was his penis in the photograph he sent. Michael later stated, "I want to make you wet." I replied, "how." Michael replied, "just going to finger you and eat you out, Till its nice and ready for my cock." I replied, "wow, ok." Later, Michael responded, "yea I want you to get freaky with me and be my bad girl." I replied, "oh ok." On June 18, 2018, Michael suggested that we meet on Thursday, June 21, 2018 at "like 1 or 2 or

morning time whatever good for you sexy." I replied, "1 is good." On June 20, 2018, I sent Michael "we still on for tomorrow?" Michael replied, "No I'm going to let it simmer." In gathering intelligence, the suspect was identified as 33-year old Michael Patton Jr. The photographs Michael provided me while chatting resembles the photo image on his Driver's license.

On July 6, 2018, at 1630 hours, I met with Michael Patton Jr at 1718 S Congress Ave, Palm Springs, Florida, while he was at work. I surreptitiously recorded the conversation inside my unmarked police vehicle. During the taped statement, Michael stated he has an iPhone 6S which is password protected and no one uses his cellular telephone. Michael stated he chatted with a fifteen year old female, but did not meet up with her. Michael acknowledged and signed the chats indicating he knew that the female he was texting was fifteen years of age and sent her sexually explicit text conversations. Michael stated he continued the conversation with the female and sent her a picture of his penis, which he signed and verified that he sent that photograph to her. Michael initialed the conversation printouts from the chatting application and the text conversations.

Based on the aforementioned facts, the suspect seduce, solicit, lure, or entice or attempt to seduce, solicit, lure, or entice a child or another person believed by the person to be a child, to engage in any illegal act such child to engage in unlawful sexual conduct violating F.S.S.847.0135(3)(a). The suspect did use his iPhone 6S, a 2 way communication device, to facilitate a felony "solicitation of a child to engage in unlawful sexual conduct" violating F.S.S. 934.215. The suspect knew or believed that he was transmitting an image that was harmful to minors violating F.S.S 847.0138(a)(b)(2).
