On the **24** day of **March**, **2018** at **00:03** (Specifically include facts constituting cause for arrest.)

On the above date at approximately 0003 hours, I was on routine patrol in the area of East Indiantown Road and US Highway One. I was traveling west, approaching the intersection.

I observed a 2008 Honda bearing Massachusetts license plate 33AP86 traveling west in the left hand through lane, directly in front of me. The vehicle stopped behind another at the red light. When the light turned to green, the vehicle turned right from the left hand through lane. There is a marked right hand turn lane at that part of the intersection. I turned behind the vehicle and began to follow it. The vehicle was drifting in its lane and drove over the white marked bicycle lane as it traveled north on North US Highway 1. I initiated a traffic stop of the vehicle as it turned right onto 1A. The vehicle pulled over to the right a short time later.

I made contact with the driver, Michael Holenko. Holenko was unusually reticent compared to the vast majority of people I have stopped and appeared to be actively avoiding speaking as much as possible. Holenko's eyes were glassy. Holenko had the odor of an unknown alcoholic beverage on his breath. Holenko handed me his driver's license and a business card for a New Hampshire State Trooper. The back of Holenko's hand struck the water bottle in the center console cup holder as he reached for his documents. Holenko denied drinking anything whatsoever. Holenko's reactions appeared to be slow and delayed.

A short time later, I asked Holenko to get out of his car. I then advised Holenko that I was starting a DUI investigation. I asked Holenko to complete SFSTs. Holenko said "no". I then advised Holenko of Taylor Warnings. I made a concentious effort to explain the tasks and the purpose of them. I again asked Holenko to complete the tasks. Holenko again declined. I placed Holenko under arrest for DUI. I directed Holenko to place his hands behind his back and I secured Holenko in handcuffs, which I checked for

spacing and double locked. A search of Holenko's vehicle revealed four small mostly empty bottles of Deep Eddy vodka. These bottles were in the driver's side door pocket. There was nothing else in the pocket. An unknown liquid was spilled on the front passenger side door. It had the odor of an unknown alcoholic beverage. There were several empty plastic cups on the front passenger side floorboard. One of the cups was wet with a small amount of unknown liquid. I then transported Holenko to the Palm Beach County Breath Alcohol Testing Facility. I conducted a 20 minute observation period. I then requested that Holenko provide a sample of his breath. Holenko declined. I read Implied Consent from a prepared text, which Holenko indicated that he understood. Holenko again declined to provide a sample of his breath. After I read Holenko his Miranda Warnings, Holenko declined to speak to me. I then secured Holenko inside a holding cell while I completed my paperwork. I then booked Holenko into the Palm Beach County Jail where I charged him with DUI per FSS 316.193(1). Officer Kolenich was on scene as my back up officer. Both Officer Kolenich and I used our issued body worn cameras while on scene.
