recorded on our body worn cameras. The Mrs. Sedransk indicated her desire to pursue prosecution.

Mrs. Sedransk reported that she and Mrs. Sedransk had been having verbal altercations and were angry with one another since last evening. This morning, the verbal discord between them continued and Mr. Sedransk verbally accosted her while she was coming out of the bathroom shower and into their bedroom. He began yelling at her and she alleged that he stated that he was going to kill her. He backed her into a corner as their verbal exchange escalated and began grasping at her about her neck and shoulders.

Mrs. Sedransk stated that she then also grasped Mr. Sedransk about his neck as the two of them mutually struggled with one another. During that struggle, Mr. Sedransk grabbed Mrs. Sedransk by the arms. Mrs. Sedransk has a medical condition which causes her to have bruising and disfigurement of her skin on her arms. As a result of Mr. Sedransk grabbing her arms, she sustained opened abrasions that were visible on her left forearm and biceps area. Mrs. Sedransk stated that he had also struck her on the left side of her face; although, aside from slight reddening of cheek and neck, no highly visible signs could be seen of those injuries, at the time of the original report. Mrs. Sedransk was photographed to document all of those reported injuries. Mrs. Sedransk declined emergency medical response.

Mr. Sedransk reported the same scenario, except that he alleged that Mrs. Sedransk grabbed him about his neck and shoulders, first. He acknowledged initiating the verbal altercation and stated that his positioning during the reported physical struggle was such that he stood between Mrs. Sedransk and the bedroom door, with his back to the door and her facing outward from the corner of the room. Slight abrasions were visible on Mr. Sedransk's neck along the area where he was wearing a gold necklace. Photographs of those injuries were photographed, as well.

Mrs. Sedransk reported that the physical and verbal abuse from Mr. Sedransk is an ongoing issue and although he is being treated by a psychiatrist and prescribed medication to treat him for mental and emotional disorders, the marital issues between them have failed to improve. She had been encouraged by her own treating physician to report the violence to law enforcement if it continued. Mrs. Sedransk reported that although she has refrained from reporting previous domestic disturbances and abuse, she was determined to report it this time in the hopes that Mr. Sedransk will be forced to realize that his agressive actions and behaviors towards her are unacceptable and will result in him making the necessary changes to save their fifty two year marriage.

Based upon the totality of the circumstances and the evidence available to us, it was determined that Mr. Sedransk was the primary agressor and therefore probable cause exists for his arrest for Domestic Battery (Simple) in violation of Florida State Statute 784.03(1)(A)(1)(b). Mr. Sedransk was placed under arrest and advised of the charge against him. He was placed into handcuff that were double locked and checked for fitment, then transported to the Palm Beach Gardens Police Department for processing, then transported to the Palm Beach County Jail where he was remanded to their care, custody, and control.

The aforementioned body worn camera video recordings, marked and time-stamped, and the evidentiary photographs are submitted to Evidence. com, along with the recordings of the 911 call to NorthCom.
