



I was stopped in the left hand turn lane. I observed a vehicle, later identified to me as a 2004 Chevrolet bearing Florida License Plate 45GDI, traveling north on South Alternate A1A at a high rate of speed. My light turned to a green arrow. I waited a moment to allow the vehicle to turn east on East Indiantown Road. I turned behind the vehicle and began to follow it. The vehicle accelerated quickly. I paced the vehicle. As I was traveling at 70 miles per hour (certified speedometer vehicle #1709), the other vehicle was still accelerating quickly away from me. I caught up with the vehicle as it slowed to turn south on South US Highway 1 from East Indiantown Road. I initiated a traffic stop a short time later as it turned into the businesses at 353 South US Highway 1. The vehicle was slow to stop but eventually turned into the parking lot and stopped.</p> <p>I made contact with the driver and sole occupant, identified to me as Michael Debriere. Debriere had bloodshot, glassy eyes. Debriere`s speech was mumbled. I could smell the odor of an unknown alcoholic beverage on Debriere`s breath. Debriere fumbled his documents as he handed them to me. Debriere stated he`d consumed one beer only when asked.</p> <p>I repositioned my vehicle in the parking space next to his to conduct Standardized Field Sobriety Tasks. Debriere agreed to complete the tasks. I observed all six standardized clues of HGN. I observed Debriere display several standardized clues in the Walk and Turn task and several in the One Leg Stand. Officer Fandrey located a bottle of Heineken beer upright on the rear passenger floorboard of the vehicle. It was cold with condensation and half empty.




I transported Debriere to the Palm Beach County Breath Alcohol Testing Facility. I conducted a 20 minute observation period. Debriere subsequently agreed to provide a sample of his breath. Debriere provided samples of .096 and .095. Debriere requested a lawyer post-Miranda. I subsequently booked Debriere into the Palm Beach County Jail, where I charged him with DUI per FSS 316.193(1).
