On June 2, 2018, complainant [redacted] came into the Palm Beach Gardens Police Department with evidence showing his roommate, Michael Arbree W/B D.O.B. 01-04-82, was in possession and had a collection of child pornography at their residence, inside Arbree's bedroom located at 4350 Union Square Blvd, Apartment 158, Palm Beach Gardens, Palm Beach County FL.

On June 3, 2018, I obtained and executed a search warrant for the residence. Inside, I was able to identify Arbree's bedroom and from that room 16 internal and external hard drives were collected.

On June 4, 2018, Palm Beach County Sheriff's Office Forensic Unit conducted a triage on some of the collected electronic items obtained during the search warrant. During the triage I observed more than 50 videos and photos of young children engaged in sexual acts. One of the collected devices from the search of Arbree's room was a Seagate external hard drive that was plugged into Arbree's computer tower. The triage report identified 20 notable video files on the Seagate External hard drive. They are listed as follows;

While in custody, post Miranda warnings, Arbree admitted that he was in possession of child pornography. Arbree admitted that he has a problem that he can't control and advised he has been viewing and in possession of child pornography for more than 10 years. Michael Victor Allison Arbree W/M D.O.B. 01-04-82 was did unlawfully and knowingly possess, control or intentionally view a photograph, motion picture, exhibition, show, representation, or other presentation which, in whole or in part, and Michael Victor Allison Arbree knew to include any sexual conduct by a child, contrary to Florida statute 827.071(5)(a). and Michael Victor Allison Arbree possessed 10 or more images of child pornography, regardless of content; and the content of at least one image contains one or more of a sexual battery involving a child, contrary to F.S.S. 775.0847.</p>
