<p>On 21Jun16 at approximately 0015hrs, victim Stephen Stewart-Williams was pedaling his white and black electric bicycle northbound along the east side of Military Trail. While Stephan was crossing the intersection of Palmetto Park Road, he was within the marked crosswalk located in unincorporated Boca Raton. At the same time, a maroon Chevy Tahoe was traveling westbound on Palmetto Park Rd traveling in the outside lane and approaching the intersection with Military Trail. This is when the Tahoe entered the crosswalk and struck Stephen and his bicycle on the passenger's side front corner of the Tahoe. As a result, the bicycle went under the passenger's side of the Tahoe and Stephen was drug approximately 20 feet. Stephen received severe abrasions and lacerations to the left side of his body which likely caused permanent scaring. The Tahoe, without stopping to render aid, fled the scene westbound on Palmetto Park Rd. Several witnesses (Tania Chouloute, Mirassania Luzincourt, and Nicholas Aleman) remained on scene while other witnesses followed the suspect vehicle.</p> <p>Per the mobile witnesses (Madeline Besser, Travis Tyson, Gerardo Navarrette, Ashleigh Miazga-Bremser, and Gregory Dirr), the Tahoe traveled westbound at a high rate of speed. It then turned right (northbound) onto St. Andrews Blvd. The witnesses stated the Tahoe was trying to evade them. The Tahoe traveled a short distance on St. Andrews Blvd and made a quick left (westbound) turn onto Town Club Blvd (Town Club Place Villas entrance). The Tahoe made a quick U-turn prior to the guardhouse and began traveling eastbound on Town Club Blvd. With the witness still following, the Tahoe then made a left turn (northbound) back onto St. Andrews Blvd. The Tahoe traveled a brief distance and made a right (eastbound) into the parking lot of Duffy's Sports Bar (21212 St. Andrews Blvd.). Finally, the Tahoe parked directly in front of Duffy's Sports Bar in the row closest to the building in the southern most spot. It should be noted that Duffy's Sports Bar was closed at this time and the parking lot located in the front of the business was empty (traditionally employees park on the side of the business). At this time, the witnesses that followed the Tahoe were able to get a positive read of the suspect vehicle's tag and immediately supply the tag number to dispatch through a 911 line (at approximately 0019hrs). The tag number they provide was a Florida specialty tag (RQM51). It should also be noted, the tag and vehicle were later discovered to be registered to W/M Richard Roselli (6025 LE LAC RD).</p>

<p>At approximately 0030hrs, employee (Vincent Bonner) from Duffy's Sports Bar exited the business and observed a blonde white female on the phone with her "mother". The employee said she was screaming and she appeared to be scared. He said the female said "Mom I am so scared. Mom listen to me. This is what I just did. This is what just happened." The employee was concerned and asked the female if she was ok. The female ignored him and got into the later identified suspect vehicle (Tahoe). The employee said she was the only one in and with the Tahoe. The employee then went back into the business. A couple minutes later the employee came out and saw the white female sitting near a canal located on the south side of the business. It was later discovered that the employee's description of the female matched the description of the registered owner's daughter, Michaela Roselli.</p> <p>Through my investigation it was discovered that at approximately 0040hrs, father/attorney Richard Roselli picked up daughter Michaela Roselli from the Duffy's Sports Bar parking lot near the "lake". He then transported Michaela to Boca Regional Hospital to have her Baker Acted. It should be noted that deputies did not discover the suspect vehicle till 0049hrs. This was when deputies arrived at Duffy's Sports Bar and located the Tahoe unoccupied in the parking lot. Additionally, the suspect vehicle was still parked in front of Duffy's Sports Bar and was the only vehicle in the lot.</p> <p>It was also discovered through investigation that while deputies were actively investigating the scene and processing the Tahoe, father Richard Roselli was attempting to have daughter Michaela Roselli Baker Acted at Boca Regional Hospital. Due to Michaela being an adult, Richard was unable to have his daughter Baker Acted. At approximately 0110hrs, Boca Raton Police Department (Officer J. Haggerty) arrived at Boca Regional Hospital. They made contact with both Richard and Michaela Roselli. Based on the information provided to them by Richard and the behavior of Michaela, Officer Haggerty Baker Acted Michaela (BRPD# 2106-9182). It should be noted Officer Haggerty's back up officers told him she appeared to be intoxicated. Additionally, the hospital staff I spoke with also believed Michaela was intoxicated.</p> <p>Upon closer view of Richard Roselli's Tahoe, impact marks were discovered on the bumper, push bumper/brush guard, and passenger side undercarriage. The above marks were consistent with witness statements and the dynamics of the crash. All these vehicle sections were photographed and placed into evidence. It should be noted Richard's vehicle did not have any signs of theft (i.e. tampering with the steering column or ignition) and was discovered to be back at his residence the day after the crash.</p> <p>Based on my investigation, I found probable cause to believe Michaela Roselli had violated F.S.S. 316.027(2)(b) Failed to Remain At Crash Scene with Serious Bodily Injury. Michaela was in physical control of her father's 2006 maroon Chevy Tahoe (RQM51) at the time of the crash with Stephen Stewart-Williams and the injuries sustained to Stephen will cause permanent scarring to the left side of his body.</p>
