Moments later, \_\_\_\_\_ looked back and observed Khoury's penis hanging out from the bottom of his shorts and his penis was erect. \_\_\_\_\_ advised officers that \_\_\_\_\_ was surprised that Khoury's penis was large for his small statue. \_\_\_\_\_ statement was captured on Ofc Reed's Body Worn Camera (BWC).  
 Sgt Jacobson made contact with Khoury inside \_\_\_\_\_. Khoury initially stated that he has a problem of touching himself. Khoury then changed his story when questioned further. Khoury stated that he was just adjusting himself and that he never touched himself inappropriately. Khoury further stated that he has erectile dysfunction and cannot get erect.  
 Based on the above facts, Probable Cause exists to charge Michel Khoury with Exposure of Sexual Organs (FSS 800.03).
