On August 12th 2018 at approximately 01:30 I was dispatched to 10908 Oak Bend Way, Wellington FL 33414 in reference to a domestic issue between two parties.

Upon arrival I was met with a very hostile individual who had been speaking with PBSO Communications, by the name of Michelle Alvarez who originally called 911 to report a domestic issue between her and her boyfriend Jeffrey Zuch. Once I arrived however, Alvarez refused to come down the street to speak with me because she said "The police would shoot her". Alvarez was belligerent, and also very intoxicated. Alvarez continued to refuse trying to speak with me about why she originally called 911, and then sat down in front of her house and told PBSO Communications "No I don't want to talk to them because they'll shoot me".

Finally once I got to speak to Alvarez, she hung up the phone and called 911 again, in front of me, stating that I wouldn't help her and she needed to speak to dispatch again. I reminded Alvarez that she would be breaking the law in reference to F.S.S 305.172(13), False 911 Calls; in reference to her calling 911 to report that her boyfriend Zuch had "hit her several times and pointed a gun at her".

Alvarez stated that at first, it was an argument and that Zuch did not have a gun. As Alvarez continued speaking to me, she then stated Zuch "showed her a handgun" after she threatened to hit him because she had found out that he had been speaking to other women on Facebook. Alvarez stated that then he pointed the gun at her, and then he put it away. Alvarez again tried to call 911 in front of me and I reminded her that that was misuse of 911 and she would now be arrested for False 911 Calls as the statute states. Alvarez continued to be belligerent and as she got closer to me, the smell of alcohol coming off of her was intense. I also spoke to Jeff Zuch, who stated that Alvarez came busting into the bedroom while he was sleeping this evening, screaming about him dating other women on Facebook, and began trying to swing her cell phone at him to hit him with it. Zuch stated that he put his hands and feet up to block Alvarez from hitting him, and then called 911 immediately and advised PBSO of the situation.

I placed Michelle Alvarez under arrest pursuant to F.S.S 305.172(13), False 911 Calls. I placed Alvarez into handcuffs which were double locked and checked for proper fit. Alvarez was then placed into the back of my patrol car and transported to West County CJ without incident.

This case is cleared by arrest. Nothing further.
