UPON COMPLETING THE ROADSIDES, I ADVISED FIGLER THAT I CONCLUDED MY DUI INVESTIGATION AND, BASED ON THE OBSERVATIONAL CLUES ON THE SFST'S, THE DRIVING PATTERN I OBSERVED, THE STRONG ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE EMANATING FROM HER BREATH AND HER ADMISSION OF CONSUMING ALCOHOL, DETERMINED THAT SHE WAS TOO IMPAIRED TO OPERATE A MOTOR VEHICLE. I PLACED FIGLER UNDER ARREST FOR DUI. SHE VERBALLY STATED THAT SHE UNDERSTOOD. I PLACED HER IN HANDCUFFS THAT WERE CHECKED FOR PROPER FIT AND TIGHTNESS AND DOUBLE LOCKED AND PLACED HER IN THE REAR OF MY PBSO MARKED PATROL VEHICLE. I TRANSPORTED FIGLER TO THE B.A.T. (BREATH ALCOHOL TESTING) FACILITY.

ONCE AT THE B.A.T. FIGLER WAS OBSERVED FOR A PERIOD OF TWENTY MINUTES, DURING WHICH TIME SHE DID NOT INGEST ANYTHING, PLACE ANYTHING IN HER MOUTH, REGURGITATE OR VOMIT. AFTER THE TWENTY MINUTE OBSERVATION PERIOD FIGLER WAS PLACED ON CAMERA AND ASKED IF SHE WOULD SUBMIT A BREATH SAMPLE FOR THE PURPOSE OF DETERMINING ITS ALCOHOL CONTENT AND SHE CONSENTED. FIGLER PROVIDED TWO BREATH SAMPLES AND THE RESULTS WERE .254 FOR THE FIRST SAMPLE AND .241 FOR THE SECOND SAMPLE. THE RESULTS WERE GIVEN, AND EXPLAINED TO HER AND SHE VERBALLY STATED THAT SHE UNDERSTOOD. I READ FIGLER HER CONSTITUTIONAL WARNINGS ON CAMERA AND SHE VERBALLY STATED THAT SHE UNDERSTOOD HER RIGHTS. SHE COOPERATED WITH Q&A.

BASED ON THE ABOVE SET OF FACTS AND CIRCUMSTANCES, PROBABLE CAUSE EXISTS TO FIND MICHELLE LEIGH FIGLER DID DRIVE OR BE IN ACTUAL PHYSICAL CONTROL OF A VEHICLE WHILE UNDER THE INFLUENCE OF ALCOHOLIC BEVERAGES, OR CHEMICAL SUBSTANCES AS SET FORTH IN FLORIDA STATUTE 877.111, OR ANY SUBSTANCE CONTROLLED UNDER CHAPTER 893 OR ANY COMBINATION THEREOF, TO THE EXTENT THAT HIS NORMAL FACULTIES WERE IMPAIRED, OR WHILE HAVING A BLOOD ALCOHOL LEVEL OF .08 OR MORE GRAMS OF ALCOHOL PER 100 MILLILITERS OF BLOOD OR BREATH ALCOHOL LEVEL OF .08 OR MORE GRAMS OF ALCOHOL PER 210 LITERS OF BREATH.

Bloodshot, red, glassy eyes. Swayed in a front to back motion while standing in a resting position. Vertical nystagmus present and observed in both eyes.

WALK & TURN:

Instructed and demonstrated. Figler verbally stated she understood the instructions. She started task before being instructed to do so. She started task too soon. Had to be repositioned while explaining task. She could not keep her balance or maintain the instructional stance while listening to instructions. She missed heel to toe (most steps). She used her arms for balance, did not count her steps out loud, stepped off line and took an incorrect number of steps.

ONE LEG STAND:

Instructed and demonstrated. Figler verbally stated she understood the instructions. She swayed while balancing. She maintained her arms up throughout the task to assist with balance. She put her foot down at least twice.

FINGER TO NOSE:

Instructed and demonstrated. Figler verbally stated she understood the instructions. Figler demonstrated proficiency with identifying her left from her right hand. She swayed in a front to back motion. She missed fingertip to nose each time L- Finger to right cheek R- Left cheek L- Side of nose R- Side of nose R- Double touch/Side of nose then knuckle to tip L- Knuckle to top of nose

ROMBERG ALPHABET:

Instructed and demonstrated. Defendant verbally stated she understood the instructions. She swayed in a front to back motion. Recited the alphabet from A to Z in a non-rhythmic manner without difficulty.



D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 08/11/2018, at approximately 11:41pm, I was traveling south on Sansbury Way in West Palm Beach, located within Palm Beach County, Florida when I observed headlights approaching me. There was a vehicle traveling north, on the wrong side of the road and approaching my marked patrol car. I activated my emergency lights and the vehicle, a white Jeep utility vehicle, merged to the left and continued traveling north on Sansbury in the center turn lane. I made a u-turn and continued behind the vehicle, with my emergency lights activated, and initiated a traffic stop. It was at that point that the white Jeep bearing Florida tag EZLB84 merged onto the northbound lane and then came to a stop. The vehicle stopped abruptly and partially drove up on to the raised curb/sidewalk.

OBSERVATION OF DRIVER:

I made contact with the driver and sole occupant of the vehicle, a white female identified as MICHELLE LEIGH FIGLER by her Florida issued driver license, and could immediately smell a strong odor of an unknown alcoholic beverage emanating from within the vehicle and her person. She was slow to respond and handed me an out dated insurance card and vehicle registration when I asked for her license and documents. Her speech was slow and slurred and her eyes were bloodshot, red and glassy. I had her exit the vehicle to relocate her to the front of my patrol car and I observed her stumble out of her car. She was unsteady on her feet but was wearing wedge style shoes. Once out of the vehicle I continued to talk to her and I could smell the strong and obvious odor of an unknown alcoholic beverage emanating from her breath as she spoke with me.

DRIVER'S STATEMENTS:

She stated that she was on her way home from picking up her car from the Kohl's parking lot. She left the car there while she went out with friends. When I asked if she consumed any alcoholic beverage she stated she had "a drink or two". I asked Figler if she would submit to voluntary SFST's and she consented. I did advise her of Taylor warnings when I did not get a clear response from her.


