Narrative:

On 6/9/2018 at approximately 0025 hours, I responded to 1308 Villa Ln (Boynton Beach - Palm Beach County) in reference to a Domestic. Reporting persons both advised Boynton Beach Police Communications that they were involved in a domestic altercation. Upon arrival, I made contact with Matthew Charles Hazlett and Michelle Marie Lund, who are boyfriend and girlfriend respectively. Hazlett and Lund have an intimate relationship and live together in the household. There are no mutual children living in the household.

Lund stated that she accompanied Hazlett to Delray Beach for dinner and alcoholic beverages. Lund stated she thinks they both drank too much, came home and started to argue. Lund stated the argument was "bad" and that she became scared that it was going to escalate into a physical altercation and that is when she notified Boynton Beach Communications of the incident. Lund had no apparent physical injuries nor did she complain of any. Lund claimed that the argument never escalated into a physical altercation to me.

I spoke with Hazlett who advised me that he had gone to dinner with Lund earlier in the evening. Hazlett stated that on the drive home Lund became agitated and was trying to exit the vehicle while it was in motion. Hazlett stated Lund was arguing with him the entire drive home. Hazlett stated he attempted to go to sleep in a different room from Lund however she disrupted his sleep and began striking him in the face and breaking sports memorabilia in the house. Hazlett had an injury on the left brow area above the eye (Scratch with blood) and an injury on the right side of his face (Scratch with blood). Photographs of these injuries were taken by Officer Barrios and placed into evidence. Hazlett was issued a Domestic Violence/ Victims Rights brochure and an Exemption From Public Records form was signed. Hazlett was offered Medical Assistance to which he declined.

Sworn statements were obtained from both subjects and while I was speaking with Hazlett, Lund spontaneously uttered to Officer Barrios that she had struck Hazlett. Based on the evidence of physical injury to Hazlett, I arrested Lund for Simple Battery - Domestic Violence (F.S.S. 784.03.1A1). Lund was processed and transported to Palm Beach County Main Detention Center for her crime.


