Upon arrival, I made contact with victim Daniel Stubbs.</p> <p>Stubbs advised me he was socializing with friends, and his girlfriend of one year, Michelle Ropp, at a restaurant in downtown Boca Raton. He said Ropp became intoxicated during dinner and started arguing with him about prior relationships. Stubbs and Ropp left together and returned to his apartment where the argument escalated. Stubbs said Ropp became physically violent and started destroying the interior of his apartment. Specifically, Ropp attempted to tear down a large painting Stubbs had hanging in his master bedroom. Stubbs put his hands out, in an attempt to calm Ropp, when she leaned toward him and bit his left armpit. Strubbs said Ropp then took his phone from his front right pocket. They began fighting over control of the phone when Ropp fled the apartment with it in her possession. It should be noted, Ropp has an apartment at 380 SE Mizner Blvd (Apartment 1709) where Stubb said she fled. Stubbs complained of an injury to his left armpit. I observed a red, raised, bite mark in the same area. Strubbs refused medical treatment. Strubbs described his phone as a black Android. He did not have a serial number at the time but would follow up with police when it becomes available.</p> <p>I then responded to 380 SE Mizner Blvd (apartment 1709) in an attempt to make contact with Ropp. While knocking on the front door, I observed a white female, matching Ropp's DAVID photo, looking through the window. She ignored all attempts to make contact and never acknowledged police at her door. Multiple attempts were made, via phone, to contact Ropp with negative results.</p> <p>Digital photos of Strubbs injuries were taken and he completed a witness statement. Documents and photos were submitted into the Boca Raton Police Department (BRPD) as</p>

<p>evidence.</p> <p>On 11/24/2016 at 0100 hours, I made contact with Jacob Ropp via phone. Jacob said his mother would meet me at BRPD to speak to officers regarding the incident.</p> <p>Ropp arrived at BRPD at approximately 0145 hours. She exited her vehicle and spoke to me regarding the incident. Ropp was immediately confrontational toward me as the investigating officer. She initially told me the argument was not about another girl. She then changed her story to say it was specifically about another girl that sent Stubbs a photo to his cell phone. Ropp continued to inform me the altercation took place inside Stubbs home where it became physical. She said Stubbs attacked her for no reason and made no mention of a phone being involved. I then specifically asked if she took his phone which incited the altercation and she said yes. After being presented with this information, she then changed her story to include the fact that she took his phone which is when he attempted to get it back. Ropp said she refused to give his phone back, and they struggled over it which resulted in Stubbs getting bit in the armpit. Ropp then left the apartment with his phone. I asked where his phone was now and she changed her story to "I threw his phone before leaving his house". It should be noted that Ropp sustained multiple injuries to her left hand, right shoulder, and right side of her throat as a result of struggling over Stubbs phone when she refused to give it back to him.</p> <p>Ropp was placed under arrest and charged pursuant to FSS 812.131(2B) (Robbery by sudden snatching without weapon) when she did knowingly take away a black Android cell phone, of some value, from Stubbs, with the intent to permanently or temporarily deprive Stubbs of the property, when in the course of the taking, Stubbs was or became aware of the taking. She was additionally charged under FSS 784.03(1) (Simple battery domestic) when she did actually and intentionally cause bodily harm to Stubbs after she bit his armpit.</p> <p>While in the booking facility at BRPD, I asked Ropp why she did not call the police and she said "because that's not my style". She also informed me that the majority of the marks on her left arm are a birthmark and not injury. Ropp refused medical treatment. She was transported to the Palm Beach County Jail without incident.</p>
