On Saturday, April 8th 2017 at 0912hrs, I responded to 4397 STEVEN RD located in unincorporated Palm Beach County Fl in reference to a domestic dispute.

Upon arrival I spoke with victim Arturo Vasquez DOB:08/12/1974 who advised me he had a physical altercation with his wife. Arturo Vasquez stated that his wife, Michelle Vasquez DOB:11/25/1983, arrived home this morning at 0500hrs, and was intoxicated. At approximately 0800hrs, Arturo Vasquez stated that [REDACTED] woke up and was asking for her mother

Michelle Vasquez to feed her.

Arturo Vasquez stated that he attempted to wake Michelle Vasquez up so she could feed their daughter. When Michelle Vasquez woke up, she became upset with Arturo Vasquez, and began arguing about Michelle Vasquez staying out until 0500hrs. Arturo Vasquez stated that the argument became "heated". Due to the "heated" argument, and the fact that there have been past domestic violence history, Arturo Vasquez stated he began to record the argument on his cell phone.

While recording the argument, Michelle Vasquez, approached Arturo Vasquez, and hit him, smacking his neck. Arturo Vasquez then presented me with the video which showed Michelle Vasquez sitting on the living room couch. While yelling at each other Michelle Vasquez is seen standing up and walking toward Arturo Vasquez. Once face to face, Michelle Vasquez is seen hitting Arturo Vasquez which knocked the cell phone from his hand. During this incident, Arturo and Michelle Vasquez daughter was sitting in the living room and observed the physical altercation.

Arturo Vasquez then pointed to the left side of his neck where he stated he was hit. I observed a light red mark just below Arturo Vasquez left ear on his neck. No other injuries were observed or reported. Arturo Vasquez denied needing medical treatment.

I then spoke with Michelle Vasquez who advised me she and her husband Arturo Vasquez have been having marital issues. Michelle Vasquez stated she became upset during a verbal argument, and confirmed she slapped her husband. Michelle Vasquez also confirmed her daughter witnessed the incident, but denied her daughter being harmed.

Based on the above facts, Michelle Vasquez was arrested for simple battery (domestic). A domestic right brochure was supplied to Arturo Vasquez along with a witness case and information form. A domestic level two call was made, and photos of Arturo Vasquez were uploaded to the domestic violence website. Due to a child being present, the Department of Children and Families were notified of the incident.
