<p>I asked the defendant if he would submit to voluntary SFST's and he verbally consented.</p> <p>Upon completing the roadsides I advised the defendant that I concluded my DUI investigation and, based on the observational clues on the SFST's and the defendant's admission of consuming alcohol, determined that he was too impaired to operate a motor vehicle and placed the defendant under arrest for DUI. The defendant verbally stated that he understood. I placed the defendant in handcuffs that were checked for proper fit and tightness and double locked and placed defendant in the rear of my PBSO marked patrol vehicle and transported the defendant to the B.A.T. (Breath Alcohol Testing) facility. Once at the B.A.T. the defendant was observed for a period of twenty minutes, during which time the defendant did not ingest anything, place anything in his mouth regurgitate or vomit. After the twenty minute observation period the defendant was placed on camera and asked if he would submit a breath sample for the purpose of determining its alcohol content and the defendant asked if he had to at which time I read Florida Implied Consent. He stated he understood Implied consent and when I asked again if he would submit a breath sample he verbally consented. The defendant provided two breath samples and the results were .180 for the first breath sample, "Volume Not Met" for the second sample and .192 for the third sample. The results were given, and explained to the defendant and the defendant verbally stated that he understood. I read the defendant his Constitutional warnings on camera and the defendant verbally stated that he understood his rights. The defendant refused to answer any questions and the Q&A portion was not completed.</p> <p>Based on the above set of facts and circumstances, probable cause exists to find MIGUEL NICANOR ZAMBRANO did drive or was in actual physical control of a vehicle, while under the influence of alcoholic beverages or chemical substances as set forth in Florida Statute 877.111, or a controlled substance as set forth in Chapter 893 or any combination thereof, and was affected to the extent that his or her normal faculties were impaired; or while having a blood alcohol level of .08 or more grams of alcohol per 100 milliliters of blood or breath alcohol level of .08 or more grams of alcohol per 210 liters of breath, contrary to Florida Statute 316.193(1). PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 07/16/2017, at approximately 0430 hours, while traveling west in the 8000 block of Okeechobee Blvd in the city of West Palm Beach, Florida (Palm Beach County) and in my PBSO marked patrol unit, I observed a vehicle approaching me from the rear which I visually estimated to be traveling faster than the posted speed limit of 50MPH. I activated my in car radar unit which emitted a clear and high Doppler tone which is indicative of a high speed. The radar unit displayed an actual speed of 76MPH. I changed lanes to allow the vehicle to pass which continued traveling westbound without reducing it's speed. I elected to initiate a traffic stop by pulling up behind the vehicle and activating my emergency lights. The vehicle, a black 4 door Mercedes bearing Florida tag 695RWG, yielded to the right shoulder within a reasonable time.

OBSERVATION OF DRIVER:

I made contact with the driver and sole occupant of the vehicle, a male identified as MIGUEL NICANOR ZAMBRANO (defendant) DOB: 05/13/1974 by his Florida issued driver's license. I observed that the defendant was slow to respond to my request of retrieving his registration form, vehicle insurance card and driver's license as he fumbled through his vehicle and wallet looking in the same places. The defendant tried to avoid eye contact with me, but when he did turn his head in my direction I saw that his eyes were red, glassy and bloodshot. He spoke in a low voice and I had to ask him to speak up. His speech was slow, heavy and slurred. I could smell a strong odor of an unknown alcoholic beverage emanating from within the vehicle and the defendant's breath as he spoke. I asked the defendant to step out of the vehicle and I observed him stumble out of the vehicle and then walked touching the side of the car as he walked back toward my patrol car. I could see that the defendant was swaying while in a standing resting position and the odor of an unknown alcoholic beverage was emanating from the defendant's breath and was getting stronger as he continued to speak.

DRIVER'S STATEMENTS:

With my in car video system activated I advised the defendant that I suspected he was impaired and I was initiating a DUI investigation and he verbally stated he understood. Zambrano stated that he was on his way home from "Respectables Club" in downtown and that he consumed to 4 ounce servings of whiskey while he was there. He denied having any medical problems or taking any medications.

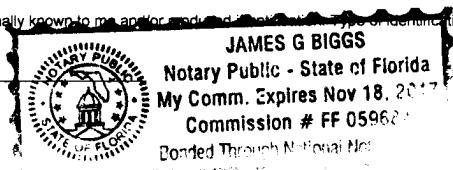

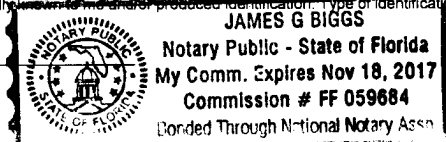
